A bill to amend 1954 PA 116, entitled "Michigan election law,"

by amending section 5090 (MCL 168.5090), as added by 1994 PA 441.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 5090. (1) The secretary of state shall direct and
- 2 supervise the establishment and maintenance of a statewide
- 3 qualified voter file. The secretary of state shall establish the
- 4 technology to implement the qualified voter file on or before
- 5 January 1, 1997. The qualified voter file shall be IS the official
- file for the conduct of all elections held in this state on or

- 1 after January 1, 1998. The secretary of state may direct that all
- 2 or any part of the city, township, or village registration files
- 3 shall be used in conjunction with the qualified voter file at the
- 4 first state primary and election held after the creation of the
- 5 qualified voter file.
- 6 (2) Notwithstanding any other provision of law to the
- 7 contrary, beginning January 1, 1998, a person who appears to vote
- 8 in an election and whose name appears in the qualified voter file
- 9 for that city, township, village, or school district is considered
- 10 a registered voter of that city, township, village, or school
- 11 district under this act.
- 12 (3) The secretary of state, a designated voter registration
- 13 agency, or a county, city, township, or village clerk shall not
- 14 place a name of an individual into the qualified voter file unless
- 15 that person signs an application as prescribed in section 509r(3).
- 16 The EXCEPT AS PROVIDED IN SUBSECTION (4), THE secretary of state or
