SENATE BILL No. 108

January 28, 2009, Introduced by Senators KAHN, GARCIA, VAN WOERKOM, KUIPERS and PAPPAGEORGE and referred to the Committee on Economic Development and Regulatory Reform.

A bill to amend 1972 PA 382, entitled "Traxler-McCauley-Law-Bowman bingo act," by amending section 3 (MCL 432.103), as amended by 2008 PA 401.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 3. As used in this act:

(a) "Educational organization" means an organization within this state that is organized not for pecuniary profit, whose primary purpose is educational in nature and designed to develop the capabilities of individuals by instruction in any public or private elementary or secondary school that complies with the revised school code, 1976 PA 451, MCL 380.1 to 380.1852, or any private or public college or university that is organized not for pecuniary profit and that is approved by the state board of education.

- 2 state, except a college fraternity or sorority, that is organized
- 3 not for pecuniary profit; that is a branch, lodge, or chapter of a
- 4 national or state organization; and that exists for the common

- 6 (c) "Licensee" means a person or qualified organization
- 7 licensed under this act.
- 8 (d) "Member" means an individual who qualified for membership
- 9 in a qualified organization under its bylaws, articles of

- 11 (e) "Michigan national guard" and "military" mean those terms
- 12 as defined in section 105 of the Michigan military act, 1967 PA
- 13 150, MCL 32.505.
- 14 (f) "Person" means a natural person, firm, association,
- 15 corporation, or other legal entity.
- 16 (g) "Qualified organization" means, subject to subdivision
- 17 (h), either of the following:
- 18 (i) A bona fide religious, educational, service, senior
- 19 citizens, fraternal, or veterans' organization that operates
- 20 without profit to its members and that either has been in existence
- 21 continuously as an organization for a period of 5 years or is
- 22 exempt from taxation under 26 USC 501(c).
- (ii) Only for the purpose of conducting a small raffle or a
- 24 large raffle under this act, a component of the military or the
- 25 Michigan national guard whose members are in active service or
- 26 active state service.
- 27 (h) "Qualified organization" does not include a candidate

- 10 (ii) A society of individuals that is organized not for
- 11 pecuniary profit and that unites for religious purposes at a

- 15 (j) "Senior citizens organization" means an organization
- 16 within this state that is organized not for pecuniary profit, that

- 19 the causes of elderly or retired persons.
- (k) "Service organization" means either of the following:
- 21 (i) A branch, lodge, or chapter of a national or state
- 22 organization that is organized not for pecuniary profit and that is
- 23 authorized by its written constitution, charter, articles of
- 24 incorporation, or bylaws to engage in a fraternal, civic, or
- 25 service purpose within the state.

- 27 pecuniary profit; that is not affiliated with a state or national

- 2 governmental subdivision in which the organization conducts its

- 6 assets are used for charitable purposes; and whose constitution,
- 7 charter, articles of incorporation, or bylaws contain a provision
- 8 that all assets, real property, and personal property shall revert
- 9 to the benefit of the local governmental subdivision that granted
- 10 the resolution upon dissolution of the organization.
- 11 (l) "Veterans' organization" means an organization within this
- 12 state, or a branch, lodge, or chapter within this state of a state
- 13 organization or of a national organization chartered by the
- 14 congress of the United States, that is organized not for pecuniary
- 15 profit, the membership of which consists of individuals who were
- 16 members of the armed services or armed forces of the United States.
- 17 VETERANS' ORGANIZATION INCLUDES AN AUXILIARY OF A VETERANS'
- 18 ORGANIZATION THAT IS A NATIONAL ORGANIZATION CHARTERED BY THE
- 19 CONGRESS OF THE UNITED STATES.
