

SENATE BILL No. 393

March 18, 2009, Introduced by Senators BASHAM, KAHN, JELINEK and PRUSI and referred to the Committee on Judiciary.

A bill to amend 1927 PA 175, entitled
"The code of criminal procedure,"
by amending section 16d of chapter XVII (MCL 777.16d), as amended
by 2005 PA 336.
