

# SENATE BILL No. 410

March 26, 2009, Introduced by Senator RICHARDVILLE and referred to the Committee on Economic Development and Regulatory Reform.

A bill to amend 1956 PA 218, entitled  
"The insurance code of 1956,"  
by amending the title, the heading of chapter 61, and sections  
3301, 3330, 4501, 6101, 6105, 6107, and 6110 (MCL 500.3301,  
500.3330, 500.4501, 500.6101, 500.6105, 500.6107, and 500.6110),  
the title as amended by 2002 PA 304, section 4501 as added by 1995  
PA 276, and sections 6101, 6105, 6107, and 6110 as added by 1992 PA  
174, and by adding sections 6104, 6104a, 6104b, and 6108; and to  
repeal acts and parts of acts.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

### TITLE

An act to revise, consolidate, and classify the laws relating  
to the insurance and surety business; to regulate the incorporation

1 or formation of domestic insurance and surety companies and  
2 associations and the admission of foreign and alien companies and  
3 associations; to provide their rights, powers, and immunities and  
4 to prescribe the conditions on which companies and associations  
5 organized, existing, or authorized under this act may exercise  
6 their powers; to provide the rights, powers, and immunities and to  
7 prescribe the conditions on which other persons, firms,  
8 corporations, associations, risk retention groups, and purchasing  
9 groups engaged in an insurance or surety business may exercise  
10 their powers; to provide for the imposition of a privilege fee on  
11 domestic insurance companies and associations and the state  
12 accident fund; to provide for the imposition of a tax on the  
13 business of foreign and alien companies and associations; to  
14 provide for the imposition of a tax on risk retention groups and  
15 purchasing groups; to provide for the imposition of a tax on the  
16 business of surplus line agents; to provide for the imposition of  
17 regulatory fees on certain insurers; to provide for assessment fees  
18 on certain health maintenance organizations; to modify tort  
19 liability arising out of certain accidents; to provide for limited  
20 actions with respect to that modified tort liability and to  
21 prescribe certain procedures for maintaining those actions; to  
22 require security for losses arising out of certain accidents; to  
23 provide for the continued availability and affordability of  
24 automobile insurance and homeowners insurance in this state and to  
25 facilitate the purchase of that insurance by all residents of this  
26 state at fair and reasonable rates; to provide for certain  
27 reporting with respect to insurance and with respect to certain

1 claims against uninsured or self-insured persons; to prescribe  
2 duties for certain state departments and officers with respect to  
3 that reporting; to provide for certain assessments; to establish  
4 and continue certain state insurance funds; to modify and clarify  
5 the status, rights, powers, duties, and operations of the nonprofit  
6 malpractice insurance fund; to provide for the departmental  
7 supervision and regulation of the insurance and surety business  
8 within this state; to provide for regulation over worker's  
9 compensation self-insurers; to provide for the conservation,  
10 rehabilitation, or liquidation of unsound or insolvent insurers; to  
11 provide for the protection of policyholders, claimants, and  
12 creditors of unsound or insolvent insurers; to provide for  
13 associations of insurers to protect policyholders and claimants in  
14 the event of insurer insolvencies; to prescribe educational  
15 requirements for insurance agents and solicitors; to provide for  
16 the regulation of multiple employer welfare arrangements; to create  
17 an automobile **INSURANCE FRAUD AND** theft prevention authority to  
18 reduce the number of automobile thefts in this state; to prescribe  
19 the powers and duties of the automobile **INSURANCE FRAUD AND** theft  
20 prevention authority; to provide certain powers and duties upon  
21 certain officials, departments, and authorities of this state; to  
22 provide for an appropriation; to repeal acts and parts of acts; and  
23 to provide penalties for the violation of this act.

24       Sec. 3301. (1) Every insurer authorized to write automobile  
25 insurance in this state shall participate in an organization for  
26 the purpose of doing all of the following:

27       (a) Providing the guarantee that automobile insurance coverage

1 will be available to any person who is unable to procure that  
2 insurance through ordinary methods.

3 (b) Preserving to the public the benefits of price competition  
4 by encouraging maximum use of the normal private insurance system.

5 **(C) PROVIDING FUNDING FOR THE MICHIGAN AUTOMOBILE INSURANCE**  
6 **FRAUD AND THEFT PREVENTION AUTHORITY.**

7 (2) The organization created under this chapter shall be  
8 called the "Michigan automobile insurance placement facility".

9 Sec. 3330. (1) The board of governors shall have all power to  
10 direct the operation of the facility, including, at a minimum, all  
11 of the following:

12 (a) To sue and be sued in the name of the facility. A judgment  
13 against the facility shall not create any liabilities in the  
14 individual participating members of the facility.

15 (b) To delegate ministerial duties, to hire a manager, to hire  
16 legal counsel, and to contract for goods and services from others.

17 (c) To assess participating members on the basis of  
18 participation ratios pursuant to section 3303 to cover anticipated  
19 costs of operation and administration of the facility, to provide  
20 for equitable servicing fees, and to share losses, profits, and  
21 expenses pursuant to the plan of operation.

22 (d) To impose limitations on cancellation or nonrenewal by  
23 participating members of facility-placed business, in addition to  
24 the limitations imposed by chapters 21 and 32.

25 (e) To provide for a limited number of participating members  
26 to receive equitable distribution of applicants; or to provide for  
27 a limited number of participating members to service applicants in

1 a plan of sharing of losses in accordance with the subsection  
2 3320(1)(c) and the plan operation.

3 (f) To provide for standards of performance of service for the  
4 participating members designated pursuant to subdivision (e).

5 (g) To adopt a plan of operation and any amendments to the  
6 plan, not inconsistent with this chapter, necessary to assure the  
7 fair, reasonable, equitable, and nondiscriminatory manner of  
8 administering the facility, including compliance with chapter 21,  
9 and to provide for such other matters as are necessary or advisable  
10 to implement this chapter, including matters necessary to comply  
11 with the requirements of chapter 21.

12 (2) The board of governors shall institute or cause to be  
13 instituted by the facility or on its behalf an automatic data  
14 processing system for recording and compiling data relative to  
15 individuals insured through the facility. An automatic data  
16 processing system established under this subsection shall, to the  
17 greatest extent possible, be made compatible with the automatic  
18 data processing system maintained by the secretary of state, to  
19 provide for the identification and review of individuals insured  
20 through the facility.

21 **(3) ON OR BEFORE JANUARY 1, 2010, THE BOARD OF GOVERNORS SHALL**  
22 **AMEND THE PLAN OF OPERATION TO ESTABLISH APPROPRIATE PROCEDURES**  
23 **NECESSARY TO MAKE ASSESSMENTS FOR AND TO CARRY OUT THE**  
24 **ADMINISTRATIVE DUTIES AND FUNCTIONS OF THE MICHIGAN AUTOMOBILE**  
25 **INSURANCE FRAUD AND THEFT PREVENTION AUTHORITY AS PROVIDED IN**  
26 **CHAPTER 61.**

27 Sec. 4501. As used in this chapter:

1 (a) "Authorized agency" means the department of state police;  
2 a city, village, or township police department; a county sheriff's  
3 department; a United States criminal investigative department or  
4 agency; the prosecuting authority of a city, village, township,  
5 county, or state or of the United States; the ~~insurance bureau~~  
6 **OFFICE OF FINANCIAL AND INSURANCE REGULATION; THE MICHIGAN**  
7 **AUTOMOBILE INSURANCE FRAUD AND THEFT PREVENTION AUTHORITY;** or the  
8 department of state.

9 (b) "Financial loss" includes, but is not limited to, loss of  
10 earnings, out-of-pocket and other expenses, repair and replacement  
11 costs, investigative costs, and claims payments.

12 (c) "Insurance policy" or "policy" means an insurance policy,  
13 health maintenance organization contract, nonprofit dental care  
14 corporation certificate, or health care corporation certificate.

15 (d) "Insurer" means a property-casualty insurer, life insurer,  
16 third party administrator, self-funded plan, health insurer, health  
17 maintenance organization, nonprofit dental care corporation, health  
18 care corporation, reinsurer, or any other entity regulated by the  
19 insurance laws of this state and providing any form of insurance.

20 **(E) "MICHIGAN AUTOMOBILE INSURANCE FRAUD AND THEFT PREVENTION**  
21 **AUTHORITY" MEANS THE MICHIGAN AUTOMOBILE INSURANCE FRAUD AND THEFT**  
22 **PREVENTION AUTHORITY CREATED UNDER SECTION 6104.**

23 **(F)** ~~(e)~~ "Organization" means an organization or internal  
24 department of an insurer established to detect and prevent  
25 insurance fraud.

26 **(G)** ~~(f)~~ "Person" includes an individual, insurer, company,  
27 association, organization, Lloyds, society, reciprocal or inter-

insurance exchange, partnership, syndicate, business trust, corporation, and any other legal entity.

(H) ~~(g)~~—"Practitioner" means a licensee of this state authorized to practice medicine and surgery, psychology, chiropractic, or law, or any other licensee of the state whose services are compensated, directly or indirectly, by insurance proceeds, or a licensee similarly licensed in other states and nations, or the practitioner of any nonmedical treatment rendered in accordance with a recognized religious method of healing.

(I) ~~(h)~~—"Statement" includes, but is not limited to, any notice statement, proof of loss, bill of lading, receipt for payment, invoice, account, estimate of property damages, bill for services, claim form, diagnosis, prescription, hospital or doctor record, X-rays, test result, or other evidence of loss, injury, or expense.

#### CHAPTER 61

##### AUTOMOBILE **INSURANCE FRAUD AND THEFT PREVENTION** AUTHORITY

Sec. 6101. As used in this chapter:

(a) "Authority" means the ~~automobile theft prevention authority~~ **MICHIGAN AUTOMOBILE INSURANCE FRAUD AND THEFT PREVENTION AUTHORITY.**

(B) "**AUTOMOBILE INSURANCE FRAUD**" MEANS A FRAUDULENT INSURANCE ACT AS DESCRIBED IN SECTION 4503, WHICH ACT IS COMMITTED IN CONNECTION WITH AN APPLICATION FOR OR A POLICY OF AUTOMOBILE INSURANCE.

(C) ~~(b)~~—"Board" means the board of directors of the **MICHIGAN** automobile **INSURANCE FRAUD AND** theft prevention authority.

1 ~~\_\_\_\_\_ (c) "Economic automobile theft" means automobile theft~~  
2 ~~perpetrated for financial gain.~~

3 (D) "CAR YEARS" MEANS NET DIRECT PRIVATE PASSENGER AND  
4 COMMERCIAL NONFLEET VEHICLE YEARS OF INSURANCE PROVIDING THE  
5 SECURITY REQUIRED BY SECTION 3101(1) WRITTEN IN THIS STATE FOR THE  
6 CALENDAR YEAR ENDING THE DECEMBER 31 OF THE SECOND PRIOR YEAR AS  
7 REPORTED TO THE STATISTICAL AGENT OF EACH INSURER.

8 (E) "FACILITY" MEANS THE MICHIGAN AUTOMOBILE INSURANCE  
9 PLACEMENT FACILITY CREATED UNDER CHAPTER 33.

10 SEC. 6104. (1) BEGINNING JANUARY 1, 2010, THE MICHIGAN  
11 AUTOMOBILE INSURANCE FRAUD AND THEFT PREVENTION AUTHORITY IS  
12 CREATED WITHIN THE FACILITY. THE FACILITY SHALL PROVIDE STAFF FOR  
13 THE AUTHORITY AND SHALL CARRY OUT THE ADMINISTRATIVE DUTIES AND  
14 FUNCTIONS AS DIRECTED BY THE BOARD OF DIRECTORS.

15 (2) THE MICHIGAN AUTOMOBILE INSURANCE FRAUD AND THEFT  
16 PREVENTION AUTHORITY IS NOT A STATE AGENCY, AND THE MONEY OF THE  
17 AUTHORITY IS NOT STATE MONEY. A RECORD OF THE AUTHORITY IS EXEMPT  
18 FROM DISCLOSURE UNDER SECTION 13 OF THE FREEDOM OF INFORMATION ACT,  
19 1976 PA 442, MCL 15.243.

20 (3) THE MICHIGAN AUTOMOBILE INSURANCE FRAUD AND THEFT  
21 PREVENTION AUTHORITY SHALL DO ALL OF THE FOLLOWING:

22 (A) PROVIDE FINANCIAL SUPPORT TO STATE OR LOCAL LAW  
23 ENFORCEMENT AGENCIES FOR PROGRAMS DESIGNED TO REDUCE THE INCIDENCE  
24 OF AUTOMOBILE INSURANCE FRAUD AND THEFT.

25 (B) PROVIDE FINANCIAL SUPPORT TO STATE OR LOCAL PROSECUTORIAL  
26 AGENCIES FOR PROGRAMS DESIGNED TO REDUCE THE INCIDENCE OF  
27 AUTOMOBILE INSURANCE FRAUD AND THEFT.

1           (4) THE MICHIGAN AUTOMOBILE INSURANCE FRAUD AND THEFT  
2 PREVENTION AUTHORITY MAY PROVIDE FINANCIAL SUPPORT TO LAW  
3 ENFORCEMENT, PROSECUTORIAL, INSURANCE, EDUCATION, OR TRAINING  
4 ASSOCIATIONS FOR PROGRAMS DESIGNED TO REDUCE THE INCIDENCE OF  
5 AUTOMOBILE INSURANCE FRAUD AND THEFT.

6           (5) THE PURPOSES, POWERS, AND DUTIES OF THE MICHIGAN  
7 AUTOMOBILE INSURANCE FRAUD AND THEFT PREVENTION AUTHORITY SHALL BE  
8 VESTED IN AND EXERCISED BY A BOARD OF DIRECTORS. THE BOARD OF  
9 DIRECTORS SHALL CONSIST OF 13 MEMBERS AS FOLLOWS:

10          (A) SEVEN MEMBERS WHO REPRESENT AUTOMOBILE INSURERS IN THIS  
11 STATE SUBJECT TO THE FOLLOWING:

12          (i) AT LEAST 2 MEMBERS WHO REPRESENT INSURER GROUPS WITH  
13 350,000 OR MORE CAR YEARS.

14          (ii) AT LEAST 2 MEMBERS WHO REPRESENT INSURER GROUPS WITH LESS  
15 THAN 350,000 BUT 100,000 OR MORE CAR YEARS.

16          (iii) AT LEAST 1 MEMBER WHO REPRESENTS INSURER GROUPS WITH LESS  
17 THAN 100,000 CAR YEARS.

18          (B) THE COMMISSIONER OR HIS OR HER DESIGNEE.

19          (C) THE ATTORNEY GENERAL OR HIS OR HER DESIGNEE.

20          (D) TWO MEMBERS WHO REPRESENT LAW ENFORCEMENT AGENCIES IN THIS  
21 STATE.

22          (E) ONE MEMBER WHO REPRESENTS PROSECUTING ATTORNEYS IN THIS  
23 STATE.

24          (F) ONE MEMBER WHO REPRESENTS THE GENERAL PUBLIC.

25          (6) THE INSURER MEMBERS ON THE BOARD UNDER SUBSECTION (5)  
26 SHALL BE ELECTED BY AUTOMOBILE INSURERS DOING BUSINESS IN THIS  
27 STATE FROM A LIST OF NOMINEES PROPOSED BY THE BOARD OF GOVERNORS OF

1 THE FACILITY. IN PREPARING THE LIST OF NOMINEES FOR THE INSURER  
2 MEMBERS, THE BOARD OF GOVERNORS OF THE FACILITY SHALL SOLICIT  
3 NOMINATIONS FROM AUTOMOBILE INSURERS DOING BUSINESS IN THIS STATE.

4 (7) THE LAW ENFORCEMENT MEMBERS ON THE BOARD UNDER SUBSECTION  
5 (5) SHALL BE APPOINTED BY THE GOVERNOR WITH THE ADVICE AND CONSENT  
6 OF THE SENATE. IN APPOINTING THE LAW ENFORCEMENT MEMBERS, THE  
7 GOVERNOR SHALL COMPLY WITH ALL OF THE FOLLOWING:

8 (A) HE OR SHE SHALL SOLICIT INPUT FROM VARIOUS LAW ENFORCEMENT  
9 ASSOCIATIONS IN THIS STATE.

10 (B) HE OR SHE SHALL NOT APPOINT A MEMBER WHO REPRESENTS THE  
11 SAME TYPE OF LAW ENFORCEMENT AGENCY AS THE OTHER MEMBER WHO  
12 REPRESENTS LAW ENFORCEMENT AGENCIES ON THE BOARD.

13 (C) HE OR SHE SHALL NOT APPOINT A MEMBER REPRESENTING THE SAME  
14 LAW ENFORCEMENT AGENCY TO THE BOARD FOR MORE THAN 2 CONSECUTIVE  
15 TERMS.

16 (8) THE PROSECUTING ATTORNEY MEMBER ON THE BOARD UNDER  
17 SUBSECTION (5) SHALL BE APPOINTED BY THE GOVERNOR WITH THE ADVICE  
18 AND CONSENT OF THE SENATE. IN APPOINTING THE PROSECUTING ATTORNEY  
19 MEMBER, THE GOVERNOR SHALL SOLICIT INPUT FROM VARIOUS PROSECUTING  
20 ATTORNEY ASSOCIATIONS IN THIS STATE.

21 (9) THE PUBLIC MEMBER ON THE BOARD UNDER SUBSECTION (5) SHALL  
22 BE APPOINTED BY THE GOVERNOR WITH THE ADVICE AND CONSENT OF THE  
23 SENATE. THE PUBLIC MEMBER SHALL BE A RESIDENT OF THIS STATE AND  
24 SHALL NOT BE EMPLOYED BY OR UNDER CONTRACT WITH ANY STATE OR LOCAL  
25 UNIT OF GOVERNMENT OR ANY INSURER.

26 (10) EXCEPT AS OTHERWISE PROVIDED IN THIS SUBSECTION, MEMBERS  
27 OF THE BOARD SHALL SERVE FOR A TERM OF 4 YEARS AND UNTIL THEIR

1 SUCCESSORS ARE APPOINTED AND QUALIFIED. FOR THE MEMBERS FIRST  
2 ELECTED OR APPOINTED UNDER THIS SECTION, 2 INSURER MEMBERS AND 1  
3 LAW ENFORCEMENT MEMBER SHALL SERVE FOR A TERM OF 2 YEARS; 3 INSURER  
4 MEMBERS, THE PROSECUTING ATTORNEY MEMBER, AND THE GENERAL PUBLIC  
5 MEMBER SHALL SERVE FOR A TERM OF 3 YEARS; AND 2 INSURER MEMBERS AND  
6 1 LAW ENFORCEMENT MEMBER SHALL SERVE FOR A TERM OF 4 YEARS.

7 SEC. 6104A. (1) MEMBERS OF THE BOARD SHALL SERVE WITHOUT  
8 COMPENSATION FOR THEIR MEMBERSHIP ON THE BOARD, EXCEPT THAT MEMBERS  
9 OF THE BOARD SHALL RECEIVE REASONABLE REIMBURSEMENT FOR NECESSARY  
10 TRAVEL AND EXPENSES.

11 (2) A MAJORITY OF THE MEMBERS OF THE BOARD SHALL CONSTITUTE A  
12 QUORUM FOR THE TRANSACTION OF BUSINESS AT A MEETING, OR THE  
13 EXERCISE OF A POWER OR FUNCTION OF THE AUTHORITY, NOTWITHSTANDING  
14 THE EXISTENCE OF 1 OR MORE VACANCIES. NOTWITHSTANDING ANY OTHER  
15 PROVISION OF LAW, ACTION MAY BE TAKEN BY THE AUTHORITY AT A MEETING  
16 UPON A VOTE OF THE MAJORITY OF ITS MEMBERS PRESENT IN PERSON OR  
17 THROUGH THE USE OF AMPLIFIED TELEPHONIC EQUIPMENT, IF AUTHORIZED BY  
18 THE BYLAWS OR PLAN OF OPERATION OF THE BOARD. THE AUTHORITY SHALL  
19 MEET AT THE CALL OF THE CHAIR OR AS MAY BE PROVIDED IN THE BYLAWS  
20 OF THE AUTHORITY. MEETINGS OF THE AUTHORITY MAY BE HELD ANYWHERE  
21 WITHIN THE STATE OF MICHIGAN.

22 (3) THE BOARD SHALL ADOPT A PLAN OF OPERATION BY A MAJORITY  
23 VOTE OF THE BOARD. VACANCIES ON THE BOARD SHALL BE FILLED IN  
24 ACCORDANCE WITH THE PLAN OF OPERATION.

25 SEC. 6104B. ON OR BEFORE JANUARY 1, 2010, THE DEPARTMENT OF  
26 STATE POLICE SHALL TRANSFER ALL ASSETS OF THE AUTOMOBILE THEFT  
27 PREVENTION AUTHORITY TO THE FACILITY FOR THE BENEFIT OF THE

1 **MICHIGAN AUTOMOBILE INSURANCE FRAUD AND THEFT PREVENTION AUTHORITY.**

2       Sec. 6105. The ~~authority~~ **BOARD** shall have the powers necessary  
3 ~~or convenient to carry out and effectuate the purposes and~~  
4 ~~provisions of this chapter and the purposes of the authority and~~  
5 ~~the powers delegated by other laws~~ **ITS DUTIES UNDER THIS ACT,**  
6 including, but not limited to, the power to **DO THE FOLLOWING:**

7       (a) Sue and be sued ~~, to have a seal and alter the same at~~

17       (d) Procure insurance against any loss in connection with its

19       (e) Invest any money held in reserve or sinking funds, or any  
20 money not required for immediate use or disbursement, at its  
21 discretion and to name and use depositories for its money.

22       (f) Contract for goods and services and engage personnel as is  
23 necessary. ~~, including the services of private consultants,~~  
24 ~~managers, counsel, auditors, and others for rendering professional,~~  
25 ~~management, and technical assistance and advice, payable out of any~~  
26 ~~money of the fund legally available for this purpose.~~

27       (g) Indemnify and procure insurance indemnifying any member of

1 the board from personal loss or accountability from liability  
 2 resulting from a member's action or inaction as a member of the  
 3 board.

4 ~~(h) Do all other things necessary or convenient to achieve the~~  
 5 ~~objectives and purposes of the authority, this chapter, or other~~  
 6 ~~laws~~ **PERFORM OTHER ACTS NOT SPECIFICALLY ENUMERATED IN THIS SECTION**  
 7 **THAT ARE NECESSARY OR PROPER TO ACCOMPLISH THE PURPOSES OF THE**  
 8 **AUTHORITY AND THAT ARE NOT INCONSISTENT WITH THIS SECTION OR THE**  
 9 **PLAN OF OPERATION.**

10 Sec. 6107. (1) Prior to April 1 of each year, each insurer  
 11 engaged in writing insurance coverages ~~which~~ **THAT** provide the  
 12 security required by section 3101(1) within this state, as a  
 13 condition of its authority to transact insurance in this state,  
 14 shall pay to the ~~authority~~ **FACILITY, FOR DEPOSIT INTO THE ACCOUNT**  
 15 **OF THE AUTHORITY**, an assessment equal to ~~\$1.00~~ **\$2.00** multiplied by  
 16 the insurer's total ~~earned~~ car years of insurance. ~~providing the~~
