An act to provide for the establishment of cooperative libraries; to prescribe the powers and duties of the department of history, arts, and libraries STATE; to provide state aid for public libraries participating in cooperative libraries; to prescribe the powers and duties of cooperative library boards; to provide an appropriation; and to repeal acts and parts of acts.

- 1 Sec. 2. As used in this act:
- 2 (a) "Department" means the department of history, arts, and
- 3 libraries STATE.
- 4 (b) "Local board" means the board of trustees or directors
- 5 that has as its primary purpose the supervision of a local public
- 6 library, or that board contracting for library service, or, if such
- 7 a board does not exist, the legislative body of the local
- 8 government that maintains the public library.
- 9 (c) "Local support" means funds from tax sources, gifts,
