## **SENATE BILL No. 566**

May 12, 2009, Introduced by Senators OLSHOVE, BIRKHOLZ, BARCIA, ANDERSON, CHERRY and WHITMER and referred to the Committee on Judiciary.

A bill to amend 1949 PA 300, entitled "Michigan vehicle code,"

by amending section 743 (MCL 257.743), as amended by 2006 PA 298.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 743. (1) A citation issued pursuant to UNDER section 742
- 2 shall contain the name of the state or political subdivision acting
- 3 as plaintiff, the name and address of the person to whom the
- 4 citation is issued, the civil infraction alleged, the place where
- 5 the person shall appear in court, the telephone number of the
  - court, the time at or by which the appearance shall be made, and
  - the additional information required by this section.
    - (2) The citation shall inform the defendant to the effect that

- 1 he or she, at or by the time specified for appearance, may DO 1 OF
- 2 THE FOLLOWING:
- 3 (a) Admit responsibility for the civil infraction in person,
- 4 by representation, or by mail.
- 5 (b) Admit responsibility for the civil infraction "with
- 6 explanation" in person, by representation, or by mail.
- 7 (c) Deny responsibility for the civil infraction by doing
- 8 either of the following:
- 9 (i) Appearing in person for an informal hearing before a
- 10 district court magistrate or a judge without the opportunity of
- 11 being represented by an attorney.
- 12 (ii) Appearing in court for a formal hearing before a judge,
- 13 with the opportunity of being represented by an attorney.
- 14 (3) The citation shall inform the defendant that if the person
- 15 desires to admit responsibility "with explanation" other than by
- 16 mail or to have an informal hearing or a formal hearing, the person
- 17 must apply to the court in person, by mail, or by telephone, within
- 18 the time specified for appearance and obtain a scheduled date and
- 19 time to appear for a hearing. A hearing date may be specified on
- 20 the citation.
- 21 (4) The citation shall contain a notice in boldface BOLDFACED
- 22 type that the failure of a person to appear within the time
- 23 specified in the citation or at the time scheduled for a hearing or
- 24 appearance will result in entry of a default judgment against the
- 25 person and in the immediate suspension of the person's operator's
- 26 or chauffeur's license. Timely application to the court for a
- 27 hearing or return of the citation with an admission of

- 1 responsibility and with full payment of applicable civil fines and
- 2 costs constitute a timely appearance.
- 3 (5) If the citation is issued to a person who is operating a
- 4 commercial motor vehicle, the citation shall contain a vehicle
- 5 group designation and indorsement description of the vehicle  $\tau$
- 6 which vehicle is THAT WAS operated by the person at the time of the
- 7 alleged civil infraction.
- 8 (6) THE CITATION SHALL CONTAIN A NOTICE THAT IF THE CITATION
- 9 WAS ISSUED FOR FAILING TO HAVE PROOF OF INSURANCE, THE PERSON CAN
- 10 HAVE THE VIOLATION DISMISSED BY PROVIDING PROOF OF INSURANCE TO THE
- 11 COURT BEFORE THE APPEARANCE DATE SET FOR THE VIOLATION AND, IF THE
- 12 PERSON FAILS TO PROVIDE PROOF OF INSURANCE BEFORE THAT DATE AND THE
- 13 COURT DETERMINES THE INDIVIDUAL IS RESPONSIBLE FOR THE VIOLATION,
- 14 THE CITATION MAY RESULT IN THE ASSESSMENT OF A DRIVER
- 15 RESPONSIBILITY FEE IN ADDITION TO THE FINE IMPOSED FOR THE
- 16 VIOLATION.
