SENATE BILL No. 704

July 15, 2009, Introduced by Senators JACOBS, RICHARDVILLE, KAHN and BIRKHOLZ and referred to the Committee on Banking and Financial Institutions.

A bill to amend 1931 PA 328, entitled "The Michigan penal code," by amending sections 159g and 411j (MCL 750.159g and 750.411j),

section 159g as amended by 2002 PA 124 and section 411j as amended by 2002 PA 136.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 26 statute of that state that is substantially similar to a violation
- 27 listed in subdivisions (a) through (ii).

- 1 Sec. 411j. As used in this section and sections 411k to 411q:
- 2 (a) "Controlled substance offense" means a felony violation of

- **4** MCL 333.7401 to 333.7461, and 333.17766a, concerning controlled
- 5 substances. or androgenic anabolic steroids.

- 7 approval or prior actual knowledge of the board of directors, a
- 8 majority of the directors, or persons who together hold a majority
- 9 of the voting ownership interests in the corporation. In

- 11 knowledge of the activity, a director who was not aware of the
- 12 activity due to his or her own negligence or other fault is
- 13 regarded as having had knowledge of the activity. This subdivision
- 14 does not limit the liability of any individual officer, employee,
