A bill to amend 1954 PA 116, entitled "Michigan election law,"

(MCL 168.1 to 168.992) by adding section 642c.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 642C. (1) EXCEPT AS OTHERWISE PROVIDED IN THIS SECTION,
- 2 BEGINNING JANUARY 1, 2010, A SCHOOL DISTRICT SHALL HOLD ITS REGULAR
- 3 ELECTION FOR THE OFFICE OF SCHOOL BOARD MEMBER ON 1 OF THE
- 4 FOLLOWING:
 - (A) THE GENERAL NOVEMBER ELECTION.
 - (B) THE EVEN YEAR AUGUST ELECTION.
 - (C) THE ODD YEAR GENERAL ELECTION, BUT ONLY IF ALL OF THE
 - FOLLOWING CONDITIONS ARE MET:
- 9 (i) AT LEAST 1 CITY THAT IS LOCATED EITHER WHOLLY OR PARTLY IN
- 10 THE SCHOOL DISTRICT CONDUCTS AN ODD YEAR GENERAL ELECTION.
 - (ii) THE CITY OR CITIES DESCRIBED IN SUBPARAGRAPH (i) CONTAIN

- 17 (4) IF A SCHOOL DISTRICT'S SCHOOL BOARD FAILS TO ADOPT A
- 18 RESOLUTION BEFORE JANUARY 1, 2010 TO HOLD ITS REGULAR ELECTION ON A
- 19 DATE IN COMPLIANCE WITH THIS SECTION, BEGINNING JANUARY 1, 2010,
- 20 THAT SCHOOL DISTRICT SHALL HOLD ITS REGULAR ELECTION AT THE EVEN
- 21 YEAR AUGUST ELECTION.
- 22 (5) AFTER DECEMBER 31, 2009, A SCHOOL DISTRICT IS NOT
- 23 PERMITTED TO CHANGE THE DATE OF ITS REGULAR ELECTION.
- 24 Enacting section 1. This amendatory act takes effect January
- **25** 1, 2010.
- 26 Enacting section 2. This amendatory act does not take effect
