## **SENATE BILL No. 881**

September 30, 2009, Introduced by Senator SWITALSKI and referred to the Committee on Campaign and Election Oversight.

A bill to amend 1954 PA 116, entitled "Michigan election law,"

(MCL 168.1 to 168.992) by adding section 317.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 317. (1) BEGINNING JANUARY 1, 2010 AND THROUGH DECEMBER
- 2 31, 2011, THE SECRETARY OF STATE SHALL ESTABLISH A PILOT PROJECT TO
- 3 TEST THE FOLLOWING IN SCHOOL DISTRICT ELECTIONS:
- 4 (A) INTERNET VOTING.
  - (B) VOTING BY MAIL.
    - (C) A COMBINATION OF INTERNET VOTING AND VOTING BY MAIL.
  - (2) THE SECRETARY OF STATE SHALL SELECT NOT FEWER THAN 6 OR
- 8 MORE THAN 12 SCHOOL DISTRICTS TO TEST INTERNET VOTING, VOTING BY
- 9 MAIL, OR A COMBINATION OF INTERNET VOTING AND VOTING BY MAIL IN
- 0 COMPLIANCE WITH THIS SECTION. THE SECRETARY OF STATE SHALL APPROVE

- 14 SHALL COOPERATE WITH THE SECRETARY OF STATE IN CONDUCTING A PILOT

- 16 BY MAIL, OR A COMBINATION OF INTERNET VOTING AND VOTING BY MAIL.
- 17 (4) THE SECRETARY OF STATE SHALL IMPLEMENT INTERNET VOTING,

- 23 (6) BEFORE MARCH 31, 2012, THE SECRETARY OF STATE SHALL SUBMIT
- 24 A REPORT TO THE HOUSE AND SENATE COMMITTEES THAT CONSIDER ELECTION
- 25 ISSUES. THE SECRETARY OF STATE SHALL INCLUDE ALL OF THE FOLLOWING
- 26 IN THE REPORT FOR EACH PILOT PROJECT SCHOOL DISTRICT:
- 27 (A) THE COST OF EACH SCHOOL DISTRICT ELECTION THAT UTILIZES

- 12 (F) ANY OTHER INFORMATION THE SECRETARY OF STATE CONSIDERS
- 13 RELEVANT.
- 14 (7) AS USED IN THIS SECTION:
- 15 (A) "INTERNET VOTING" MEANS THE ACT OF VOTING IN A SCHOOL
- 16 DISTRICT ELECTION BY A QUALIFIED AND REGISTERED ELECTOR UTILIZING
- 17 THE INTERNET AT HOME OR UTILIZING AN INTERNET VOTING SYSTEM.
- 18 (B) "INTERNET VOTING SYSTEM" MEANS A VOTING SYSTEM AT A
- 19 POLLING PLACE APPROVED FOR USE BY THE BOARD OF STATE CANVASSERS
- 20 THAT ALLOWS AN ELECTOR TO SECRETLY AND SECURELY TRANSMIT HIS OR HER
- 21 VOTED BALLOT TO ELECTIONS OFFICIALS BY UTILIZING THE INTERNET.
- 22 (C) "LARGE SCHOOL DISTRICT" MEANS A SCHOOL DISTRICT WITH 5,000
- 23 OR MORE PUPILS.
- 24 (D) "RURAL SCHOOL DISTRICT" MEANS A SCHOOL DISTRICT THAT HAS A
- 25 POPULATION DENSITY OF 100 OR FEWER PERSONS PER SQUARE MILE AS
- 26 DETERMINED BY THE MOST RECENT FEDERAL DECENNIAL CENSUS.
- 27 (E) "SMALL SCHOOL DISTRICT" MEANS A SCHOOL DISTRICT WITH LESS
