

SENATE BILL No. 1033

December 17, 2009, Introduced by Senator THOMAS and referred to the Committee on Transportation.

A bill to amend 1982 PA 432, entitled
"Motor bus transportation act,"
by amending section 4 (MCL 474.104), as amended by 1989 PA 233.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 4. (1) ~~This~~ **EXCEPT AS OTHERWISE PROVIDED IN SUBSECTION**
2 **(2), THIS** act shall not apply to a motor carrier of passengers that
3 is any of the following:

4 (a) A county, city, township, or village as provided by law,

6 (2) A motor carrier of passengers exempt under subsection (1)
7 shall operate under the requirements of this act when operating
8 outside of the political subdivisions permitted by the authorizing
9 statute, **AN INTERLOCAL AGREEMENT UNDER THE URBAN COOPERATION ACT OF**
10 **1967, 1967 (EX SESS) PA 7, MCL 124.501 TO 124.512,** or the contract
11 required by the authorizing statute.

12 Enacting section 1. This amendatory act takes effect October
13 1, 2010.

14 Enacting section 2. This amendatory act does not take effect
15 unless Senate Bill No. 1031

16 of the 95th Legislature is enacted into law.
