

# SENATE BILL No. 1045

December 18, 2009, Introduced by Senators GLEASON, GILBERT, GEORGE, BIRKHOLZ, CHERRY, BASHAM, CLARKE, JACOBS, WHITMER, ANDERSON, CLARK-COLEMAN, BARCIA, SWITALSKI, OLSHOVE, PRUSI, SCOTT, THOMAS, BRATER, KUIPERS, HUNTER, STAMAS, SANBORN, CROPSEY and RICHARDVILLE and referred to the Committee on Transportation.

A bill to amend 2006 PA 384, entitled  
"Driver education provider and instructor act,"  
by amending section 39 (MCL 256.659).

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1       Sec. 39. A segment 2 curriculum course provided under this act  
2 shall meet ~~both~~ **ALL** of the following requirements:

3       (a) Be offered only to a student who has done all of the  
4 following:

5       (i) Successfully completed a segment 1 curriculum driver  
6 education course.

7       (ii) Held a valid level 1 graduated driver license for not less  
8 than 3 continuous months.

9       (iii) Acquired 30 or more hours driving experience on a level 1  
10 graduated driver license that includes not less than 2 hours of

1 night driving with a licensed parent or legal guardian, or with the  
2 permission of a parent or legal guardian, with any licensed driver  
3 who is 21 years of age or older.

4 (b) Contain 6 or more hours of classroom instruction that is  
5 scheduled so the student receives not more than 2 hours of  
6 classroom instruction per day.

7 (C) PROVIDE INSTRUCTION EXPLAINING THE RIGHT TO MAKE AN  
8 ANATOMICAL GIFT IN THE EVENT OF DEATH UNDER PART 101 OF THE PUBLIC  
9 HEALTH CODE, 1978 PA 368, MCL 333.10101 TO 333.10123. INSTRUCTIONAL  
10 MATERIALS TO EFFECTUATE THIS SUBDIVISION SHALL BE DEVELOPED IN  
11 COOPERATION WITH THE FEDERALLY DESIGNATED ORGAN PROCUREMENT  
12 ORGANIZATION FOR THIS STATE AND SHALL INCLUDE INFORMATION ON HOW TO  
13 JOIN THE STATE ORGAN, TISSUE, AND EYE DONOR REGISTRY. THE FOLLOWING  
14 APPLY TO INSTRUCTION PROVIDED UNDER THIS SUBDIVISION:

15 (i) IF INSTRUCTION MATERIAL IS PROVIDED AT NO COST TO THE  
16 DRIVER EDUCATION PROVIDER IN AN ELECTRONIC MEDIUM, THE PROVIDER  
17 SHALL SHOW THE INSTRUCTION MATERIAL TO ITS STUDENTS.

18 (ii) IF INSTRUCTION MATERIAL IS PROVIDED AT NO COST TO THE  
19 DRIVER EDUCATION PROVIDER IN THE FORM OF A BROCHURE OR OTHER  
20 WRITTEN MATERIAL, THE PROVIDER SHALL PROVIDE THE MATERIAL TO ITS  
21 STUDENTS.
