## **SENATE BILL No. 1313**

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 81E. (1) EXCEPT AS OTHERWISE PROVIDED IN THIS SECTION, A
- 2 PERSON WHO ASSAULTS, BATTERS, OR ASSAULTS AND BATTERS AN INDIVIDUAL
- 3 WHILE THE INDIVIDUAL IS PERFORMING HIS OR HER DUTIES AS AN EMPLOYEE
- OR CONTRACTOR OF A PUBLIC UTILITY OR BECAUSE OF THE INDIVIDUAL'S
- 5 STATUS AS AN EMPLOYEE OR CONTRACTOR OF A PUBLIC UTILITY IS GUILTY
- OF A MISDEMEANOR PUNISHABLE BY IMPRISONMENT FOR NOT MORE THAN 1
  - YEAR OR A FINE OF NOT MORE THAN \$1,000.00, OR BOTH.
- 8 (2) A PERSON WHO ASSAULTS, BATTERS, OR ASSAULTS AND BATTERS AN
  - INDIVIDUAL WHILE THE INDIVIDUAL IS PERFORMING HIS OR HER DUTIES AS
