

# SENATE BILL No. 1461

August 17, 2010, Introduced by Senators ANDERSON, CHERRY, SWITALSKI, BASHAM, WHITMER, JACOBS, BRATER, CLARK-COLEMAN, THOMAS and SCOTT and referred to the Committee on Judiciary.

A bill to amend 1927 PA 175, entitled  
"The code of criminal procedure,"  
by amending section 16t of chapter XVII (MCL 777.16t), as amended  
by 2008 PA 565.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

### CHAPTER XVII

Sec. 16t. This chapter applies to the following felonies
