

SENATE BILL No. 1545

November 3, 2010, Introduced by Senators ANDERSON, CHERRY, WHITMER, OLSHOVE and THOMAS and referred to the Committee on Natural Resources and Environmental Affairs.

A bill to amend 1994 PA 451, entitled
"Natural resources and environmental protection act,"
(MCL 324.101 to 324.90106) by adding sections 61803 and 61804.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 SEC. 61803. (1) A PERSON THAT OWNS OR OPERATES A PIPELINE IN
2 THIS STATE SHALL PREPARE AND SUBMIT TO THE DEPARTMENT AND THE
3 COMMISSION AN EMERGENCY RESPONSE PLAN.

4 (2) AN EMERGENCY RESPONSE PLAN PREPARED UNDER THIS SECTION
5 SHALL CONTAIN ALL OF THE FOLLOWING:

6 (A) ALL INFORMATION REQUIRED FOR EMERGENCY RESPONSE PLANS
7 UNDER 49 CFR 194.

8 (B) ADDITIONAL INFORMATION REQUIRED BY RULE.

9 SEC. 61804. THE OWNER OR OPERATOR OF A PIPELINE IN THIS STATE
10 SHALL CONDUCT RELEASE RESPONSE DRILLS AT A FREQUENCY DETERMINED BY

1 RULE TO PRACTICE IMPLEMENTING THE OWNER'S OR OPERATOR'S EMERGENCY
2 RESPONSE PLAN IN THE EVENT OF A RELEASE FROM THE PIPELINE. THE
3 RELEASE RESPONSE DRILL SHALL INCLUDE NOTIFICATIONS OF LOCAL UNITS
4 OF GOVERNMENT IN THE VICINITY OF THE PIPELINE THAT MAY BE ABLE TO
5 ASSIST IN RELEASE RESPONSE IF A RELEASE FROM THE PIPELINE OCCURS.

6 Enacting section 1. This amendatory act does not take effect
7 unless all of the following bills of the 95th Legislature are
8 enacted into law:
