SENATE BILL No. 1580

November 4, 2010, Introduced by Senator PAPPAGEORGE and referred to the Committee on Economic Development and Regulatory Reform.

A bill to amend 1968 PA 251, entitled "Cemetery regulation act,"

by amending section 10 (MCL 456.530), as amended by 2008 PA 478.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

Sec. 10. (1) The commissioner shall institute and maintain a
system of auditing trust funds required by this act and of

- registering each cemetery authorized to be created, maintained, and
- 4 operated in this state, as well as any other cemetery operating
- 5 under state law or local ordinance. A cemetery owned and operated
- 6 by a municipal corporation, church, or religious institution, OR A
- 7 CORPORATION THAT HAS MORE THAN 48% OWNERSHIP BY A QUALIFIED CHARITY
- 8 is exempt from this act. BEGINNING THE EFFECTIVE DATE OF THE
- 9 AMENDATORY ACT THAT ADDED THIS SENTENCE, A CORPORATION THAT HAS

- 1 MORE THAN 48% OWNERSHIP BY A QUALIFIED CHARITY AND THAT IS SEEKING
- 2 EXEMPTION FROM THIS ACT UNDER THIS SUBSECTION SHALL NOTIFY THE
- 3 COMMISSIONER IN WRITING AND SUBMIT A STATEMENT COMPOSED BY AN
- 4 INDEPENDENT MICHIGAN-LICENSED CERTIFIED PUBLIC ACCOUNTANT
- 5 DESCRIBING AND CERTIFYING THE NATURE OF THE CHARITABLE OWNERSHIP OF
- 6 THE CORPORATION. ANNUALLY THEREAFTER, THE CORPORATION SHALL SUBMIT
- 7 SUCH A STATEMENT IN ORDER TO MAINTAIN ITS EXEMPTION UNDER THIS
- 8 SUBSECTION. WITHIN 30 DAYS AFTER THE CORPORATION IS DETERMINED TO
- 9 HAVE FALLEN BELOW THE OVER-48% OWNERSHIP REQUIREMENT, THE
- 10 CORPORATION IS CONSIDERED SUBJECT TO THIS ACT AND SHALL NOTIFY THE
- 11 COMMISSIONER IN WRITING. However, a municipal corporation may pass
- 12 ordinances necessary for regulating that municipal corporation's
- 13 cemeteries.
- 14 (2) A cemetery for earth interment of 10 acres or less in
- 15 size, which is owned and operated entirely and exclusively by an
- 16 existing nonprofit entity and in which a burial has taken place
- 17 before September 15, 1968, is exempt from the fee provisions of
- 18 this act, shall have the trust fund required by this act audited at
- 19 the discretion of the commissioner, and is exempt from the
- 20 endowment care trust fund requirements of section 16, except for
- 21 the report requirements if the cemetery maintains endowment and
- 22 perpetual care trust funds.
- 23 (3) AS USED IN THIS SECTION, "QUALIFIED CHARITY" MEANS A
- 24 CHARITABLE TRUST OR ENTITY THAT EITHER QUALIFIES UNDER SECTION
- 25 5012(C)(3) OF THE INTERNAL REVENUE CODE, 26 USC 501, OR IS A TRUST
- 26 IN WHICH THE SOLE BENEFICIARY OF THE TRUST IS THE CEMETERY.
