## A SUMMARY OF HOUSE BILL 4718 AS REPORTED FROM COMMITTEE 4-26-12

The bill would allow a dental assistant to function as a "second pair of hands" for a dental hygienist under the supervision of a dentist.

A dental assistant or dental hygienist may only perform certain tasks under the direct delegation or supervision of a licensed dentist. Currently, a dental assistant or a dental hygienist may function as a "second pair of hands" for a dentist who is in the process of rendering dental services and treatment to a patient. As defined in R 338.11101 of the Administrative Code, the term "second pair of hands" refers to acts, tasks, functions, and procedures performed by a dental assistant, registered dental assistant, or registered dental hygienist at the direction of a dentist who is in the process of rendering dental services to a patient. The acts, tasks, etc. must be ancillary to the procedures being performed by the dentist and intended to provide help and assistance at the time the procedures are performed.

<u>House Bill 4718</u> would add a new section to the Public Health Code to allow a dental hygienist to utilize a dental assistant to act as his or her second pair of hands. The bill would also allow a dental assistant to function as a second pair of hand for a dentist or dental hygienist if all of the following conditions were met:

- The dentist or dental hygienist was actively performing services in the mouth of a patient at the time the dental assistant was assisting the dentist or hygienist.
- If the dental assistant is assisting a dental hygienist, a supervising dentist has assigned the dental assistant to act as the dental hygienist's second pair of hands.

The bill would not require new or additional third party reimbursement or mandated worker's compensation benefits for services rendered by an individual licensed as a dental assistant or as a dental hygienist under Article 15 of the health code.
