Senate Bills 1258 (Substitute S-1) Senate Bills 1259 (Substitute S-1) Sponsor: Senator Mark C. Jansen

CONTENT

The bills would extend for three years certain fee sunsets for licensing and regulatory fees collected by the Department of Licensing and Regulatory Affairs (LARA). Under current law, these fees will be reduced by varying amounts on October 1, 2012. The fiscal year 2012-13 LARA budget was passed using fee revenue that was anticipated to be generated by the extension or elimination of these sunsets. Details for each of the fees are in the sections below.

Senate Bill 1258 (S-1)

The bill would extend for three years the fee sunsets as established by the Uniform Securities Act for the following fees:

The bill also would establish the "Licensing and Regulation Fund" in the Department of Treasury. All revenue from the fees in the previous table would be deposited to that Fund for use in offsetting the costs of the Department of Licensing and Regulatory Affairs. Currently, these fees are deposited in the General Fund, but are used to offset LARA's costs.

Finally, the bill would modify sections that allow LARA to charge fees for examinations, and require an annual report on the fees charged by each third-party exam administrator for each examination. Additionally, the bill would specify that certain exam fees only apply if LARA accepts the exam administrator with the lowest exam fee.

FISCAL IMPACT

The bills would have a significant and positive fiscal impact on the Department of Licensing and Regulatory Affairs. In total, the bills would prevent the loss of approximately \$8,321,000 due to statutory reductions in fees that otherwise will go into effect on October 1, 2012. The fiscal year 2012-13 LARA budget included revenue from these fees at levels consistent with that received in previous fiscal years; that is, the budget was passed assuming the sunsets on these fees would be delayed or eliminated.
