A bill to amend 1953 PA 232, entitled "Corrections code of 1953,"

by amending sections 62b and 62c (MCL 791.262b and 791.262c), section 62b as amended by 2000 PA 211 and section 62c as amended by 1988 PA 293.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

Sec. 62b. (1) The rules and standards promulgated under section 62(3) shall DO not prohibit the housing of 2 inmates in a county jail cell which THAT is designed and constructed for single occupancy and which THAT meets either of the following conditions:

(a) The cell is at least 65 square feet in area and provides

[unrestricted] access to a day area which is available for use by the inmates other than those inmates being disciplined. The day area shall be available at least 14 hours per day and shall contain an

- 2 (b) The cell is at least 55 square feet in area and both of
