## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 448. (1) THE DEPARTMENT SHALL ISSUE DIRECTIVES REQUIRING
- 2 ALL STATE AGENCIES TO PROVIDE THE DEPARTMENT WITH, AND TO MAKE
- 3 AVAILABLE THROUGH A LINK ON THEIR WEBSITE HOMEPAGES, ALL OF THE
- 4 FOLLOWING INFORMATION REGARDING THE EXPENDITURE OF STATE FUNDS:
- 5 (A) THE NAME OF THE ENTITY RECEIVING THE FUNDS.
- 6 (B) THE AMOUNT OF STATE FUNDS.
- 7 (C) THE FUNDING STATE AGENCY.
- 8 (D) A DESCRIPTIVE PURPOSE OF THE FUNDING ACTION OR
- 9 EXPENDITURE.

- 1 (E) ANY OTHER INFORMATION REQUIRED BY THE DEPARTMENT.
- 2 (2) NOT LATER THAN JANUARY 1, 2013, THE DEPARTMENT SHALL
- 3 DEVELOP AND OPERATE A SEARCHABLE WEBSITE ACCESSIBLE BY THE PUBLIC
- 4 AT NO COST TO ACCESS THE INFORMATION PROVIDED IN SUBSECTION (1).
- 5 (3) NOTHING IN THIS SECTION SHALL REQUIRE THE DISCLOSURE OF
- 6 INFORMATION THAT IS CONSIDERED CONFIDENTIAL BY STATE OR FEDERAL
- 7 LAW.
- 8 (4) AS USED IN THIS SECTION, "EXPENDITURE OF STATE FUNDS"
- 9 MEANS AN EXPENDITURE OF APPROPRIATED OR NONAPPROPRIATED FUNDS
- 10 PROCESSED THROUGH THE STATE'S CENTRAL ACCOUNTING SYSTEM BY AN
- 11 EXECUTIVE BRANCH AGENCY THAT INCLUDES, BUT IS NOT LIMITED TO, ALL
- 12 OF THE FOLLOWING:
- 13 (A) STATE PURCHASES.
- 14 (B) CONTRACTS AND SUBCONTRACTS.
- 15 (C) GRANTS.
