SUBSTITUTE FOR HOUSE BILL NO. 4700

A bill to amend 1976 PA 451, entitled "The revised school code,"

(MCL 380.1 to 380.1852) by adding section 1255a.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 1255A. (1) IF A SCHOOL DISTRICT, INTERMEDIATE SCHOOL
- 2 DISTRICT, OR PUBLIC SCHOOL ACADEMY HAS 100 OR MORE EMPLOYEES IN A
- 3 MEDICAL BENEFIT PLAN, OR PARTICIPATES IN AN ARRANGEMENT OR LETTER
- 4 OF INTENT DESCRIBED IN SECTION 15(2) OF THE PUBLIC EMPLOYEES HEALTH
- 5 BENEFIT ACT, 2007 PA 106, MCL 124.85, FOR A MEDICAL BENEFIT PLAN
- 6 FOR 100 OR MORE PUBLIC EMPLOYEES, THE BOARD OF THE SCHOOL DISTRICT
- 7 OR INTERMEDIATE SCHOOL DISTRICT OR BOARD OF DIRECTORS OF THE PUBLIC
- 8 SCHOOL ACADEMY SHALL NOT ENTER INTO A CONTRACT FOR THAT MEDICAL
- 9 BENEFIT PLAN UNLESS THE CONTRACT PROVIDES FOR 1 OF THE FOLLOWING:

- (A) THAT THE SCHOOL DISTRICT, INTERMEDIATE SCHOOL DISTRICT, OR 1
- 2 PUBLIC SCHOOL ACADEMY IS A POLICYHOLDER FOR THE MEDICAL BENEFIT
- 3 PLAN AND, AT ALL TIMES DURING THE PERIOD OF THE CONTRACT, THE
- 4 SCHOOL DISTRICT, INTERMEDIATE SCHOOL DISTRICT, OR PUBLIC SCHOOL
- 5 ACADEMY WILL HAVE ACCESS BY ELECTRONIC MEANS TO AT LEAST ALL OF THE
- CLAIMS UTILIZATION AND COST INFORMATION DESCRIBED IN SECTION 15 OF
- 7 THE PUBLIC EMPLOYEES HEALTH BENEFIT ACT, 2007 PA 106, MCL 124.85.
- (B) THAT, WITHIN 10 BUSINESS DAYS AFTER MAKING A WRITTEN 8
- 9 REQUEST, THE SCHOOL DISTRICT, INTERMEDIATE SCHOOL DISTRICT, OR
- 10 PUBLIC SCHOOL ACADEMY WILL BE GIVEN ACCESS BY ELECTRONIC MEANS TO
- 11 AT LEAST ALL OF THE CLAIMS UTILIZATION AND COST INFORMATION
- DESCRIBED IN SECTION 15 OF THE PUBLIC EMPLOYEES HEALTH BENEFIT ACT, 12
- 13 2007 PA 106, MCL 124.85.
- 14 (2) FOR A MEDICAL BENEFIT PLAN PROVIDED BY A SCHOOL DISTRICT,
- 15 INTERMEDIATE SCHOOL DISTRICT, OR PUBLIC SCHOOL ACADEMY FOR FEWER
- 16 THAN 100 EMPLOYEES, SUBSECTION (1) DOES NOT AFFECT THE ABILITY OF
- 17 THE SCHOOL DISTRICT, INTERMEDIATE SCHOOL DISTRICT, OR PUBLIC SCHOOL
- 18 ACADEMY TO BE A POLICYHOLDER FOR THE MEDICAL BENEFIT PLAN.
- 19 (3) AS USED IN THIS SECTION, "MEDICAL BENEFIT PLAN" MEANS THAT
- 20 TERM AS DEFINED IN SECTION 3 OF THE PUBLIC EMPLOYEES HEALTH BENEFIT
