## HOUSE SUBSTITUTE FOR SENATE BILL NO. 640

## A bill to amend 1911 PA 209, entitled

"An act to adopt and prescribe the design of a state coat-of-arms and state flag, and their use, and to prohibit the use of the same for advertising purposes, and to provide a punishment for such forbidden use,"

(MCL 2.21 to 2.27) by amending the title and by adding section 2a.

- 8 BOARDS, COMMISSIONS, AUTHORITIES, OR OTHER AGENCIES OF THIS STATE,
- 9 SHALL NOT PURCHASE A FLAG OF THE UNITED STATES OR STATE FLAG OF
- 10 MICHIGAN FOR RESALE UNLESS THE FLAG WAS MANUFACTURED IN THE UNITED
- 11 STATES [OR A TERRITORY OF THE UNITED STATES].
- 12 (3) THIS SECTION DOES NOT APPLY TO LOCAL UNITS OF GOVERNMENT.
