- 4 Sec. 3. (1) "Average daily attendance", for the purposes of
- 5 complying with federal law, means 92% of the pupils counted in
- 6 membership on the pupil membership count day, as defined in section
- **7** 6(7).
- 8 (2) "Board" means the governing body of a district or public
- 9 school academy.
- 10 (3) "Center" means the center for educational performance and
- 11 information created in section 94a.
- 12 (4) "Cooperative education program" means a written voluntary
- 13 agreement between and among districts to provide certain
- 14 educational programs for pupils in certain groups of districts. The
- 15 written agreement shall be approved by all affected districts at
- 16 least annually and shall specify the educational programs to be
- 17 provided and the estimated number of pupils from each district who
- 18 will participate in the educational programs.
- 19 (5) "Department", except in section 107, means the department
- 20 of education.
- 21 (6) "District" means a local school district established under

- 16 (4) "Membership", except as otherwise provided in this act,
- 17 ARTICLE, means for a district, public school academy, university
- 18 school, or intermediate district the sum of the product of .75
- 19 times the number of full-time equated pupils in grades K to 12
- 20 actually enrolled and in regular daily attendance on the pupil
- 21 membership count day for the current school year, plus the product
- of .25 times the final audited count from the supplemental count
- 23 day for the immediately preceding school year. All pupil counts

- 18 (g) A pupil enrolled in a university school shall be counted
- in membership in the university school.

- 24 for the first 2 full or partial fiscal years of operation shall be

- 17 (j) If a district is the authorizing body for a public school
