**HOUSE BILL No. 4233** 

by amending section 1229 (MCL 380.1229), as added by 1995 PA 289.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 1229. (1) The EXCEPT AS OTHERWISE PROVIDED IN SUBSECTION
- 2 (4), THE board of a school district, other than a school district
- 3 that was organized as a primary school district during the 1995-
- 4 1996 school year, or **OF AN** intermediate school district shall
- 5 employ a superintendent of schools, who shall meet the requirements
- 6 of section 1246. The superintendent shall not be a member of the
- 7 board. Employment of a superintendent shall be by written contract.
- B The term of the superintendent's contract shall be fixed by the
- 9 board, not to exceed 5 years. If written notice of nonrenewal of
- 10 the contract of a superintendent is not given at least 90 days

- 1 before the termination of the contract, the contract is renewed for
- 2 an additional 1-year period.
- 3 (2) The board of a school district or intermediate school
- 4 district may employ assistant superintendents, principals,
- 5 assistant principals, guidance directors, and other administrators
- 6 who do not assume tenure in that position under Act No. 4 of the
- 7 Public Acts of the Extra Session of 1937, being sections 38.71 to
- 8 38.191 of the Michigan Compiled Laws. 1937 (EX SESS) PA 4, MCL
- 9 38.71 TO 38.191. The employment shall be by written contract. The
- 10 term of the employment contract shall be fixed by the board, not to
- 11 exceed 3 years. The board shall prescribe the duties of a person
- 12 described in this subsection. If written notice of nonrenewal of
- 13 the contract of a person described in this subsection is not given
- 14 at least 60 days before the termination date of the contract, the
- 15 contract is renewed for an additional 1-year period.
- 16 (3) A notification of nonrenewal of contract of a person
- 17 described in subsection (2) may be given only for a reason that is
- 18 not arbitrary or capricious. The board shall not issue a notice of
- 19 nonrenewal under this section unless the affected person has been
- 20 provided with not less than 30 days' advance notice that the board
- 21 is considering the nonrenewal together with a written statement of
- 22 the reasons the board is considering the nonrenewal. After the
- 23 issuance of the written statement, but before the nonrenewal
- 24 statement is issued, the affected person shall be given the
- 25 opportunity to meet with not less than a majority of the board to
- 26 discuss the reasons stated in the written statement. The meeting
- 27 shall be open to the public or a closed session, as the affected

- 9 (4) A SCHOOL DISTRICT, INSTEAD OF DIRECTLY EMPLOYING A

- 11 SCHOOL DISTRICT FOR THE INTERMEDIATE SUPERINTENDENT TO SERVE AS THE
- 12 SUPERINTENDENT OF SCHOOLS FOR THE SCHOOL DISTRICT OR FOR THE
- 13 INTERMEDIATE SCHOOL DISTRICT TO PROVIDE ANOTHER PERSON TO SERVE AS
- 14 SUPERINTENDENT OF SCHOOLS FOR THE SCHOOL DISTRICT.
