- 24 (x) $\frac{(ix)}{(ix)}$ One hundred and twenty days for a permit under section

- 26 (xi) $\frac{(x)}{(x)}$ One hundred fifty days for a permit under section
- 27 36505. However, if a site inspection or federal approval is

- 1 required, the 150-day period is tolled pending completion of the
- 2 inspection or receipt of the federal approval.
- 3 (xii) (xi) For any other permit, 150 days or, if a hearing is
- 4 held, 90 days after the hearing, whichever is later.
- 5 Sec. 1307. (1) By the processing deadline, the department
- 6 shall approve or deny an application for a permit. If requested by
- 7 the permit applicant, the department may extend the processing
- 8 period for a permit by not more than 20%. Approval of an
- 9 application for a permit may be granted with conditions or
- 10 modifications necessary to achieve compliance with the part or
- 11 parts of this act under which the permit is issued.

- 3 approved and the department shall be considered to have made any

- 5 (5) The failure of the department to satisfy the requirements
- 6 of subsection (1) or the fact that the department is required to
- 7 make a payment under subsection (3) or is considered to have
- 8 approved a permit under subsection (4) shall not be used by the
- 9 department as the basis for discriminating against the applicant.
- 10 If the department is required to make a payment under subsection
- 11 (3), the application shall be processed in sequence with other

- which the processing period began, unless the director determines
- 14 on an application-by-application basis that the public interest is

- 16 (6) If the department fails to satisfy the requirements of
- 17 subsection (1), the director shall notify the appropriations
- 18 committees of the senate and house of representatives of the
- 19 failure. The notification shall be in writing and shall include

- 22 (b) A statement of the amount the department was required to
- 23 pay the applicant under subsection (3) or a statement that the

- 26 Sec. 30102. (1) Except as provided in this part, a person
- 27 without a permit from the department shall not do any of the

- 3 (b) Construct, enlarge, extend, remove, or place a structure
- 4 on bottomland.
- 5 (c) Construct, reconfigure, or expand a marina.
- 6 (d) Create, enlarge, or diminish an inland lake or stream.
- 7 (e) Structurally interfere with the natural flow of an inland
- 8 lake or stream.
- 9 (f) Construct, dredge, commence, extend, or enlarge an
- 10 artificial canal, channel, ditch, lagoon, pond, lake, or similar

- 18 (2) A PERSON SHALL NOT REMOVE SUBMERGED LOGS FROM RIVERS OR
- 19 STREAMS FOR THE PURPOSE OF SUBMERGED LOG RECOVERY. THIS SUBSECTION
- 20 DOES NOT PROHIBIT THE DEPARTMENT FROM ISSUING A PERMIT UNDER THIS
- 21 PART FOR OTHER PURPOSES, INCLUDING REMOVING LOGJAMS OR REMOVING
- 22 LOGS THAT INTERFERE WITH NAVIGATION OF THE RIVER OR STREAM.
- 23 Sec. 30104. (1) A person shall not undertake a project subject
- 24 to this part except as authorized by a permit issued by the

- 25 of seawalls, bulkheads, or revetments of 500 feet or more.

- 27 subdivision (c) (v), involving any of the following, a fee of

- 18 (E) FOR THE REMOVAL OF SUBMERGED LOGS FROM BOTTOMLAND OF AN
- 19 INLAND LAKE, A \$500.00 FEE.
- **20 (F)** (e) For all other projects not listed in subdivisions (a)
- 21 through $\frac{(d)}{(E)}$, a fee of \$500.00.
- 22 (3) A project that requires review and approval under this
- 23 part and 1 or more of the following acts or parts of acts is
- 24 subject to only the single highest permit fee required under this
- 25 part or the following acts or parts of acts:
- **26** (a) Part 303.
- **27** (b) Part 323.

- 1 (c) Part 325.
- 2 (d) Section 3104.
- 3 (e) Section 117 of the land division act, 1967 PA 288, MCL
- **4** 560.117.
- 5 (4) If work has been done in violation of a permit requirement
- 6 under this part and restoration is not ordered by the department,
- 7 the department may accept an application for a permit if the
- 8 application is accompanied by a fee equal to 2 times the permit fee
- 9 required under this section.
- 10 Sec. 32603. (1) A person shall obtain a permit from the
- 11 department under this part prior to removing NOT REMOVE submerged
- 12 logs from bottomlands EXCEPT AS AUTHORIZED BY A PERMIT ISSUED BY
- 13 THE DEPARTMENT PURSUANT TO PART 13.
- 14 (2) The department may issue a permit under this part to a
- 15 person for the removal of submerged logs from patented lands if
- 16 permission is received from the lawful owner of the patented lands.
- 17 (3) A person shall not recover, alter, or destroy abandoned
- 18 property as defined in part 761 while engaging in submerged log
- 19 removal operations under a submerged log removal permit issued
- 20 under this part.
- 21 (4) For submerged log recovery in underwater preserves
- 22 established under part 761, the department shall place REASONABLE
- 23 conditions on submerged log removal permits to prevent damage to
- 24 abandoned watercraft or other features of archaeological,
- 25 historical, recreational, or environmental significance and to
- 26 minimize conflicts between recreational activities within the
- 27 preserve and the submerged log recovery operation.

- 1 Sec. 32604. (1) For calendar year 2000, the department shall
- 2 establish a time period for the submission of applications for
- 3 submerged log removal permits under this part. Beginning in 2001,
- 4 and each year thereafter, applications APPLICATIONS FOR SUBMERGED
- 5 LOG REMOVAL PERMITS shall be submitted before February 1 of each
- 6 calendar year. However, the department shall not issue a submerged
- 7 log removal permit under this part after December 31, 2003.
- 8 (2) An application for a submerged log removal permit shall be
- 9 submitted in writing on a form provided by the department and shall
- include all of the following:
- 11 (a) A description of the proposed bottomland log removal area
- 12 with boundaries delineated by THE USE OF CURRENT TECHNOLOGY SUCH AS
- 13 a digital global positioning system or other technology approved by
- 14 the department. The proposed bottomland log removal area shall be a
- 15 contiguous area of not more than 320 acres. The area proposed shall
- 16 be square or rectangular in shape, and the length shall not exceed
- 17 the width by more than a factor of 6.
- 18 (b) A description of the methods to be used to raise the
- 19 submerged logs, the time of year during which submerged logs will
- 20 be raised, and the procedures to be used for transferring logs to
- 21 the shore.
- (c) Identification of any adverse environmental impacts
- 23 associated with the proposed submerged log removal method.
- 24 (d) Identification of the steps proposed to mitigate any
- 25 adverse environmental impacts caused by the proposed submerged log
- 26 removal operation.
- (e) Other information that the department considers necessary

- 1 in evaluating a submerged log removal permit application.
- 2 (f) A \$3,500.00 \$500.00 application fee.
- 3 (3) An application for a submerged log removal permit is not
- 4 complete until all information requested on the application form
- 5 and any other information requested by the department are received.
- 6 Within 30 days of its receipt of an application, the department
- 7 shall notify the applicant in writing if the application is
- 8 deficient. The applicant shall submit the requested information to
- 9 the department within 30 days after the date the notice is
- 10 provided. If the applicant fails to respond within the 30-day
- 11 period, the department shall deny the submerged log removal permit
- 12 unless the applicant requests and the department approves an
- 13 extension of time based upon the applicant's reasonable
- 14 justification for the extension.
- 15 (4) Application fees received under this section shall be
- 16 forwarded to the state treasurer for deposit into the fund.
- 17 Sec. 32606. (1) The department shall review each complete
- 18 application received for a submerged log removal permit and shall
- 19 not issue a permit unless the department determines both of the
- 20 following:
- 21 (a) That any adverse impacts, including, but not limited to,
- 22 impacts to the environment, natural resources, riparian rights, and
- 23 the public trust are minimal and will be mitigated to the extent
- 24 practicable.
- 25 (b) That the proposed activity will not unreasonably affect
- 26 the public health, safety, and welfare.
- 27 (2) The department may determine that certain areas within a

- 1 proposed bottomland log removal area described in an application
- 2 for a submerged log removal permit shall not be authorized for
- 3 submerged log removal based upon adverse impacts, including, but
- 4 not limited to, adverse impacts to the environment, natural
- 5 resources, riparian rights, and the public trust.
- 6 (3) The department shall make a decision on whether or not to
- 7 issue a submerged log removal permit under this part within 90 days
- 8 after the close of the review and comment period under section
- 9 32605 or, if a public hearing is held under section 32608, within
- 10 90 days after the date of that public hearing.
- 11 (4) IF THE DEPARTMENT ISSUES A SUBMERGED LOG REMOVAL PERMIT,
- 12 THE DEPARTMENT SHALL CONDITION THE PERMIT ON COMPLIANCE WITH BOTH
- 13 OF THE FOLLOWING:
- 14 (A) THE PERMITTEE HAS PROVIDED THE DEPARTMENT WITH A \$3,000.00
- 15 LOG RECOVERY FEE.
- 16 (B) THE PERMITTEE HAS PROVIDED THE DEPARTMENT A BOND AS
- 17 REQUIRED IN SECTION 32607(7).
- 18 (5) THE DEPARTMENT SHALL NOTIFY THE APPLICANT IN WRITING

- 21 (6) THE DEPARTMENT SHALL FORWARD LOG RECOVERY FEES RECEIVED
- 22 UNDER THIS SUBSECTION TO THE STATE TREASURER FOR DEPOSIT INTO THE
- 23 GREAT LAKES FUND CREATED IN SECTION 32611.
- Sec. 32607. (1) The department shall not authorize the same
- 25 bottomland log removal area in more than 1 submerged log removal
- 26 permit at any 1 time.
- 27 (2) The department may modify the boundaries of a proposed

- 1 bottomland log removal area in a submerged log removal permit to
- 2 avoid overlaps with other active submerged log removal permits or
- 3 adverse impacts, including, but not limited to, impacts to the
- 4 environment, natural resources, riparian rights, and the public
- 5 trust.
- 6 (3) A submerged log removal plan approved by the department
- 7 shall be included in each submerged log removal permit.
- 8 (4) A submerged log removal permit shall contain terms and
- 9 conditions that are determined by the department to protect the

- 20 Processing fees received under this subsection shall be forwarded
- 21 to the state treasurer for deposit into the fund.
- 22 (6) A submerged log removal permit issued under this section
- 23 is not transferrable unless THE TRANSFER IS approved in writing by
- 24 the department.
- 25 (7) An applicant for a submerged log removal permit shall
- 26 provide a performance—bond acceptable to the department in the
- 27 amount of NOT LESS THAN \$10,000.00 OR MORE THAN \$100,000.00 AS

- 1 REQUIRED BY THE DEPARTMENT, BASED UPON PERMIT CONDITIONS INCLUDING
- 2 COSTS OF RESTORATION AND PAYMENTS UNDER SECTION 32609. EXCEPT AS
- 3 PROVIDED IN SUBSECTION (8), THE TERM OF THE BOND SHALL EXTEND FOR 1
- 4 YEAR FOLLOWING THE EXPIRATION OF THE SUBMERGED LOG REMOVAL PERMIT.
- 5 The performance bond shall be provided to the department at least
- 6 10 days prior to beginning submerged log removal in a bottomland
- 7 log removal area. The performance—bond shall ensure compliance with
- 8 the submerged log removal permit for the period of the permit or
- 9 until the authorized submerged log removal is completed to the
- 10 satisfaction of the department and all REQUIRED payments under
- 11 section 32609. have been made. The IF A SUBMERGED LOG REMOVAL
- 12 PERMIT IS TERMINATED UNDER SUBSECTION (8), THE department shall
- 13 issue a written statement releasing the permittee and OR bonding
- 14 company, upon termination of the submerged log removal permit and
- 15 OR BOTH, upon satisfaction of the department as to the compliance
- 16 of the permittee with the terms and conditions of the permit . The
- 17 department may draw upon the performance bond for delinquent AND
- 18 SATISFACTION OF ALL payments as required in section 32609.
- 19 (8) A permittee may request, in writing, and the department
- 20 may grant, termination of a submerged log removal permit prior to
- 21 the expiration date, including release from quarterly reports and
- 22 performance bond requirements.
- 23 (9) AS USED IN THE SECTION, "BOND" MEANS A PERFORMANCE BOND
- 24 FROM A SURETY COMPANY AUTHORIZED TO TRANSACT BUSINESS IN THIS STATE
- 25 OR AN IRREVOCABLE LETTER OF CREDIT, IN FAVOR OF THE DEPARTMENT.
- 26 Sec. 32609. (1) The state reserves a payment of $2.0 \pm 15\%$
- 27 OF THE sawlog stumpage value for OF each submerged log that is

- 1 removed from unpatented lands. As used in this subsection, "sawlog
- 2 stumpage value" means the most recent average value of standing
- 3 timber on state forestlands for each species as determined and
