SUBSTITUTE FOR HOUSE BILL NO. 5391

A bill to authorize transit service providers to fingerprint certain individuals for the purpose of receiving criminal history record information from the department of state police and the federal bureau of investigation; to prescribe the powers and duties of certain state departments and officers; and to provide for the collection of fees.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 2 (a) "Bus" means a motor bus as defined in section 3 of the

- 4 (b) "Criminal history record information" means that term as
- 5 defined in section 1a of 1925 PA 289, MCL 28.241a.
- 6 (c) "Employee" means an individual applying for employment as

- 1 a bus driver with a transit service provider.
- 2 (d) "Transit service provider" means a public transportation
- 3 authority formed under any of the following:

- 19 (e) "Vulnerable population" means children, the elderly, or
- 20 individuals with disabilities.
- 21 Sec. 2. (1) Notwithstanding any other provision of law to the
- 22 contrary, a transit service provider may require the fingerprinting
- 23 of an employee who comes into contact with a vulnerable population
- 24 for the purpose of obtaining criminal history record information.
- 25 Fingerprints obtained pursuant to this section may be submitted to
- 26 the department of state police for a state criminal history record
- 27 check or to the federal bureau of investigation for a national

- 1 criminal history record check.
- 2 (2) A fingerprint-based criminal history check under this act
- 3 shall be conducted in a manner prescribed by the department of
- 4 state police. The department of state police shall conduct the
- 5 fingerprint-based criminal history check and provide a report of
- 6 the results to the requesting transit service provider. The report
- 7 shall indicate whether the employee has been convicted of a
- 8 violation or attempted violation of any of the following:
- 9 (a) Criminal sexual conduct, assault with intent to commit
- 10 criminal sexual conduct, or an attempt to commit criminal sexual
- 11 conduct, in any degree under sections 520b to 520g of the Michigan
- 12 penal code, 1931 PA 328, MCL 750.520b to 750.520g.
- 13 (b) A felony involving a criminal assault or battery on an
- 14 individual.
- 15 (c) A crime involving felonious assault on a child, child
- 16 abuse in the first degree, cruelty, torture, or indecent exposure
- 17 involving a child.
- 18 (d) A felony involving the manufacture, distribution, or
- 19 dispensing of a controlled substance or possession with intent to
- 20 manufacture, distribute, or dispense a controlled substance.
- 21 (e) A felony conviction involving fraud as an element of the
- 22 crime.
- 23 (f) A violation of section 625(1), (3), or (8) of the Michigan
- 24 vehicle code, 1949 PA 300, MCL 257.625.
- 25 (g) A violation of section 145n of the Michigan penal code,
- 26 1931 PA 328, MCL 750.145n.
- 27 (3) The department of state police may charge a fee for the

- 1 fingerprint-based criminal history check. A fee for a fingerprint-
- 2 based criminal history check charged under this subsection shall
- 3 not exceed the actual and reasonable cost of conducting the check.
- 4 (4) A transit service provider that fingerprints employees
- 5 under this section shall develop a written fingerprint policy and
- 6 shall provide those employees with a written synopsis of the
- 7 fingerprinting policy that describes how fingerprints are taken, to
- 8 whom the fingerprints are sent, and how the fingerprints are used.
- 9 (5) The department of state police shall store and maintain
- 10 all fingerprints submitted under this act in an automated
- 11 fingerprint identification system database that provides for an
- 12 automatic notification when a subsequent criminal arrest
- 13 fingerprint card submitted into the system matches a set of
- 14 fingerprints previously submitted in accordance with this act. Upon
- 15 a match, the department of state police shall immediately notify
- 16 the transit service provider that employs the employee.
- 17 (6) Any criminal history data kept on file by the transit
- 18 service provider are exempt from disclosure under section 13(1)(d)
- 19 of the freedom of information act, 1976 PA 442, MCL 15.243.
- 20 Enacting section 1. This act takes effect 90 days after the
- 21 date it is enacted into law.
