HOUSE SUBSTITUTE FOR SENATE BILL NO. 442

A bill to amend 1949 PA 300, entitled "Michigan vehicle code,"

by amending section 227 (MCL 257.227), as amended by 1995 PA 287; and to repeal acts and parts of acts.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 227. (1) Application for renewal of a vehicle
- 2 registration shall be made by the owner upon proper application and
- 3 by payment of the registration fee for the vehicle, as provided by
- **4** law.
- 5 (2) Every such application shall be accompanied by the
- 6 certificate of title pertaining to the vehicle, showing ownership
- 7 in the person applying for registration at the time of the
- 8 application. However, the THE secretary of state may waive the
- 9 presentation of the certificate of title.

(3) Beginning January 1, 1983, every EVERY application for 1 2 renewal of a motor vehicle registration made by mail, shall be accompanied by proof of vehicle insurance in a form determined by 3 4 the secretary of state. (4) Beginning January 1, 1981, every application for renewal 5 of a motor vehicle registration made in person at a secretary of 6 state field office shall be accompanied by proof of vehicle 7 insurance in a form determined by the secretary of state. 8 (4) (5) Notwithstanding subsections (3) and (4), SUBSECTION 9 (3), the secretary of state shall accept as proof of vehicle 10 11 insurance a transmission of the applicant's vehicle identification 12 number only POLICY INFORMATION for an insured vehicle for which vehicle registration is sought. The secretary of state may 13 determine in what format AND ON WHAT TIMELINE the secretary of 14 state will receive vehicle identification number POLICY 15 information, WHICH SHALL NOT BE REQUIRED MORE FREQUENTLY THAN EVERY 16 14 DAYS. IN DETERMINING THE FORMAT UNDER THIS SUBSECTION, THE 17 SECRETARY OF STATE SHALL CONSULT WITH INSURERS. The transmission to 18 19 the secretary of state of a THE vehicle identification number 20 POLICY INFORMATION is proof of insurance to the secretary of state 21 for motor vehicle registration purposes only and is not evidence that a policy of insurance actually exists between an insurer and 22 an individual. Vehicle identification numbers POLICY INFORMATION 23 SUBMITTED BY AN INSURER AND received by the secretary of state 24 under this subsection are IS confidential, are IS not subject to 25 26 the freedom of information act, Act No. 442 of the Public Acts of 27 1976, being sections 15.231 to 15.246 of the Michigan Compiled Laws

- 2 any person except pursuant to THE DEPARTMENT OF COMMUNITY HEALTH
- 3 FOR PURPOSES OF 2006 PA 593, MCL 550.281 TO 550.289, OR UNDER an
- 4 order by a court of competent jurisdiction in connection with a
- 5 claim or fraud investigation or prosecution.
- 6 (6) AS USED IN THIS SECTION, "POLICY INFORMATION" MEANS THE
- 7 INFORMATION AN AUTOMOBILE INSURER IS REQUIRED TO SUPPLY TO THE
- 8 SECRETARY OF STATE UNDER SECTION 3101A OF THE INSURANCE CODE OF
- 9 1956, 1956 PA 218, MCL 500.3101A.
- 10 Enacting section 1. Section 227b of the Michigan vehicle code,
- 11 1949 PA 300, MCL 257.227b, is repealed.
- 12 Enacting section 2. This amendatory act takes effect December
- **13** 30, 2011.
- 14 Enacting section 3. This amendatory act does not take effect
- 15 unless Senate Bill No. 441 of the 96th Legislature is enacted into
- **16** law.
