SUBSTITUTE FOR SENATE BILL NO. 802

A bill to amend 1984 PA 431, entitled "The management and budget act,"

(MCL 18.1101 to 18.1594) by adding section 373.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 373. (1) BEGINNING FISCAL YEAR 2013-2014, EACH REPORTING
- 2 UNIT SHALL CLASSIFY EACH LINE ITEM IN THE ENACTED BUDGET IN 1 OF
- 3 THE FOLLOWING SPENDING CATEGORIES: CORE SERVICES, SUPPORT SERVICES,
- 4 OR WORK PROJECTS. EACH REPORTING UNIT SHALL PREPARE A SPENDING PLAN
- 5 FOR EACH LINE ITEM IN THE MOST RECENTLY ENACTED BUDGET.
- 6 (2) A SPENDING PLAN UNDER THIS SECTION SHALL DO ALL OF THE
- 7 FOLLOWING:
- 8 (A) SUMMARIZE THE LINE ITEMS BY APPROPRIATION UNIT.
- 9 (B) NOT EXCEED THE GROSS APPROPRIATION FOR THE LINE ITEM IN

- 1 THE ENACTED BUDGET. A SPENDING PLAN MAY PROPOSE A LESSER AMOUNT IF
- 2 THE FEDERAL OR STATE REVENUES ARE ANTICIPATED TO BE LESS THAN THE
- 3 AMOUNT APPROPRIATED.
- 4 (C) IDENTIFY THE BUDGET REQUIREMENTS FOR EACH CORE SERVICE,
- 5 SUPPORT SERVICE, AND WORK PROJECT TO, AT A MINIMUM, THE FOLLOWING
- 6 EXPENSE CATEGORIES:
- 7 (i) STATE EMPLOYEE SALARIES AND FRINGE BENEFITS.
- 8 (ii) PRODUCTS AND SERVICES PROVIDED BY OTHERS.
- 9 (iii) DIRECT PAYMENTS TO CLIENTS.
- 10 (iv) MEDICAL PAYMENTS ON BEHALF OF CLIENTS.
- 11 (v) EDUCATIONAL EXPENSES ON BEHALF OF CLIENTS OR STUDENTS.
- 12 (vi) ALL OTHER COSTS.
- 13 (D) IDENTIFY REVENUE SOURCES AND AMOUNTS FOR EACH
- 14 APPROPRIATION UNIT.
- 15 (3) EACH REPORTING UNIT SHALL SUBMIT ITS SPENDING PLAN TO THE
- 16 STATE BUDGET OFFICE EACH YEAR WITHIN 60 DAYS AFTER ENACTMENT OF THE
- 17 BUDGET. THE STATE BUDGET OFFICE SHALL DESIGN A STANDARDIZED
- 18 SPENDING PLAN REPORTING FORMAT AND MAKE THE REPORTING FORM
- 19 AVAILABLE FOR USE BY EACH REPORTING UNIT.
- 20 (4) WITHIN 30 DAYS AFTER RECEIVING THE SPENDING PLANS FROM THE
- 21 REPORTING UNITS, THE DIRECTOR OF THE STATE BUDGET OFFICE SHALL
- 22 REVIEW AND APPROVE EACH SPENDING PLAN OR, IF CHANGES ARE REQUESTED,
- 23 RETURN THE SPENDING PLAN TO THE REPORTING UNIT. THE REPORTING UNIT
- 24 SHALL RESUBMIT A REVISED SPENDING PLAN THAT ADDRESSES THE REQUESTED
- 25 CHANGES WITHIN 2 WEEKS. THE STATE BUDGET DIRECTOR SHALL SUBMIT EACH
- 26 APPROVED SPENDING PLAN TO THE APPROPRIATE APPROPRIATIONS
- 27 SUBCOMMITTEES AND THE SENATE AND HOUSE FISCAL AGENCIES IN A

- 1 SPREADSHEET-COMPATIBLE FORMAT, AND POST IT ON THE DEPARTMENT'S
- 2 PUBLIC WEBSITE.
- 3 (5) FOR THE FISCAL YEAR 2014-2015, THE LEGISLATURE INTENDS
- 4 THAT APPROPRIATIONS AND THE EXECUTIVE BUDGET WILL GROUP LINE-ITEM
- 5 APPROPRIATIONS INTO ONLY 3 APPROPRIATION UNITS: CORE SERVICES,
- 6 SUPPORT SERVICES, AND WORK PROJECTS. EACH REPORTING UNIT SHALL
- 7 PREPARE A SPENDING PLAN FOR EACH LINE-ITEM CATEGORY WITHIN EACH
- 8 APPROPRIATION UNIT.
- 9 (6) FOR THE FISCAL YEAR 2015-2016 AND EACH SUBSEQUENT FISCAL
- 10 YEAR, THE LEGISLATURE INTENDS THAT APPROPRIATIONS AND THE EXECUTIVE
- 11 BUDGET WILL INCLUDE A SCHEDULE OF PROGRAMS FOR EACH LINE ITEM. THE
- 12 SCHEDULE OF PROGRAMS SHALL INCLUDE SUGGESTED SPENDING AMOUNTS FOR
- 13 EACH PROGRAM LISTED.
- 14 (7) AS USED IN THIS SECTION:
- 15 (A) "APPROPRIATION UNIT" MEANS A NUMBERED SECTION IN A BUDGET
- 16 BILL THAT INCLUDES A RELATED GROUP OF DISCRETE LINE-ITEM
- 17 APPROPRIATIONS REPRESENTING THE STRUCTURE OF AN ORGANIZATION OR ITS
- 18 MAJOR PROGRAMS, THE SUM OF WHICH LINE-ITEM APPROPRIATIONS EQUALS
- 19 THE TOTAL APPROPRIATION FOR THE APPROPRIATION UNIT AND THE SUM OF
- 20 THE APPROPRIATION UNIT TOTAL EQUALS THE TOTAL APPROPRIATION FOR THE
- 21 ORGANIZATION.
- 22 (B) "CORE SERVICE" MEANS AN ACTIVITY THAT PROVIDES MEASURABLE
- 23 VALUE TO BENEFICIARIES SUCH AS CITIZENS, BUSINESSES, AND UNITS OF
- 24 LOCAL GOVERNMENT.
- 25 (C) "REPORTING UNIT" MEANS A STATE AGENCY TO WHICH AN
- 26 APPROPRIATION IS MADE.
- 27 (D) "SCHEDULE OF PROGRAMS" MEANS A LISTING OF THE PROGRAMS

- WITHIN A BUDGET THAT ARE FUNDED FROM A SPECIFIC LINE ITEM. 1
- 2 (E) "SUPPORT SERVICE" MEANS AN ACTIVITY, SUCH AS INFORMATION
- 3 TECHNOLOGY, ACCOUNTING, HUMAN RESOURCES, LEGAL, AND OTHER SUPPORT
- FUNCTIONS THAT ARE REQUIRED TO SUPPORT THE ONGOING DELIVERY OF CORE 4
- SERVICES. 5
- (F) "WORK PROJECT" MEANS THAT TERM AS DEFINED IN SECTION 404 6
- 7 AND THAT MEETS THE CRITERIA IN SECTION 451A(1).
- Enacting section 1. This amendatory act does not take effect 8
- 9 unless Senate Bill No. 21 of the 96th Legislature is enacted into
- 10 law.
