## SUBSTITUTE FOR

## SENATE BILL NO. 996

A bill to provide for indemnification for livestock killed, injured, or lost as a result of certain wildlife; and to prescribe the powers and duties of certain state agencies and officials.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 1. This act shall be known and may be cited as the
- 2 "wildlife depredations indemnification act".
- 3 Sec. 2. As used in this act:
- 4 (a) "Commission" means the commission of agriculture and rural
- 5 development.
- 6 (b) "Department" means the department of agriculture and rural
- 7 development.
- 8 (c) "Livestock" means that term as it is defined in section 5
- 9 of the animal industry act, 1988 PA 466, MCL 287.705.

- 1 Sec. 3. (1) The department shall provide indemnification for
- 2 the death, injury, or loss of livestock from wolves, coyotes, and
- 3 cougars. Indemnification for missing animals shall only be paid if
- 4 there is a history of losses to the owner of livestock as evidenced
- 5 by a prior payment by the department due to the death or injury of
- 6 livestock from wolves.
- 7 (2) To be eligible for indemnification under subsection (1),
- 8 the owner of livestock shall do all of the following:
- 9 (a) Report the incident to the department within 24 hours
- 10 after the animal is discovered to be dead, injured, or missing.
- 11 (b) File a claim for indemnification with the department
- 12 verifying the type and number of animals for which indemnification
- is sought. The verification may include photographs of the animals
- 14 or tracks or other information that provides support for the claim.
- 15 If the claim seeks indemnification for missing animals, a notarized
- 16 statement from the owner specifying the date of birth of each
- 17 missing animal and the date on which the animals were discovered
- 18 missing, along with evidence of prior indemnification payments due
- 19 to death or injury of livestock from wolves, is sufficient
- 20 documentation that 1 or more animals are missing and eligible for
- 21 indemnification.
- (c) Upon request, provide the department of natural resources
- 23 with access to the owner's property as necessary to conduct an
- 24 investigation if the department of natural resources believes that
- 25 an on-site visit will assist its investigation.
- 26 (d) Upon request, provide the department with documentation
- 27 that the animals have official identification, if required under

- 1 the animal industry act, 1988 PA 466, MCL 287.701 to 287.746.
- 2 Sec. 4. (1) Within 45 days after receipt of a claim for
- 3 indemnification, the department shall appraise and inventory the
- 4 livestock for which indemnification is sought and shall make an
- 5 indemnification payment to a person who is eliqible to receive
- 6 indemnification under this act. If the department fails to make the
- 7 indemnification payment within this 45-day time period, the person
- 8 is entitled to receive from the department twice the amount of the
- 9 original claim.
- 10 (2) Except as otherwise provided in this section, the
- 11 department shall reimburse the claimant, for each animal included
- 12 in the claim, 100% of the fair market value, on the date of the
- 13 appraisal, of livestock of that type marketable for the purpose for
- 14 which the animal was intended to be marketed, not to exceed
- 15 \$4,000.00 for each animal. The appraisal determination shall not
- 16 delay the slaughter, destruction, or disposition of the livestock
- 17 animals.
- 18 (3) The department shall deduct from the indemnification
- 19 amount under subsection (2) for any compensation received, or to be
- 20 received by the owner, from any other source, including, but not
- 21 limited to, indemnification by the United States department of
- 22 agriculture, insurance, or salvage value. The owner shall furnish
- 23 to the department all records indicating other sources of
- 24 indemnity. An affidavit signed by the owner attesting to the amount
- 25 of compensation for the livestock received, or to be received, from
- 26 any other source shall accompany the appraisal certificate prior to
- 27 the payment of indemnification under this section.

- 1 (4) The department may make an indemnification payment
- 2 pursuant to this section not to exceed \$100,000.00 per incident
- 3 which is the basis for a valid claim for indemnification under this
- 4 act, from any line item in the annual budget for the department in
- 5 the applicable fiscal year. Any agreement for an indemnification
- 6 payment greater than \$100,000.00 entered into between the
- 7 department and an owner of livestock shall contain a provision
- 8 indicating that, notwithstanding the terms of the agreement,
- 9 indemnification shall be subject to specific appropriations by the
- 10 legislature and not be paid from department funds.
- Sec. 5. (1) Acceptance of compensation under this act
- 12 constitutes a full and complete release of any claim the owner has
- 13 against this state, its departments, agencies, officers, employees,
- 14 agents, and contractors to the extent these persons were acting on
- 15 behalf of this state, within the scope of their employment with
- 16 this state or under the direction of this state, its departments,
- 17 agencies, officers, or employees related to the death, injury, or
- 18 loss of the livestock.
- 19 (2) The right to indemnity under this act does not apply to
- 20 livestock determined by the department to have been imported
- 21 without meeting import requirements such as an official interstate
- 22 health certificate or official interstate certificate of veterinary
- 23 inspection, required testing, required vaccination, or to livestock
- 24 determined by the department to have been illegally moved within
- 25 this state. An owner is not entitled to indemnity from this state
- 26 for an animal that comes into the possession of the owner with the
- 27 owner's knowledge that the animal is diseased or is suspected of

- 1 having been exposed to an infectious, contagious, or toxicological
- 2 disease. In addition, the department shall not indemnify an owner
- 3 for animals that have been exposed to an animal that comes in to
- 4 the possession of the owner with the owner's knowledge that the
- 5 animal is diseased or is suspected of having been exposed to an
- 6 infectious, contagious, or toxicological disease.
