SUBSTITUTE FOR SENATE BILL NO. 1122

A bill to amend 1978 PA 368, entitled "Public health code,"

(MCL 333.1101 to 333.25211) by adding section 9155.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 9155. (1) BEFORE THE EXPIRATION OF 90 DAYS AFTER THE
- 2 EFFECTIVE DATE OF THIS SECTION, THE DEPARTMENT SHALL DEVELOP,
- 3 ADOPT, OR APPROVE EDUCATIONAL MATERIALS IN AN ELECTRONIC FORMAT ON
- 4 THE NATURE AND RISK OF CONCUSSIONS.
- 5 (2) BEFORE THE EXPIRATION OF 90 DAYS AFTER THE EFFECTIVE DATE
- 6 OF THIS SECTION, THE DEPARTMENT SHALL DEVELOP, ADOPT, OR APPROVE A
- 7 CONCUSSION AWARENESS TRAINING PROGRAM IN AN ELECTRONIC FORMAT THAT
- 8 INCLUDES ALL OF THE FOLLOWING:
- 9 (A) THE NATURE AND RISK OF CONCUSSIONS.

- 1 (B) THE CRITERIA FOR THE REMOVAL OF AN ATHLETE FROM PHYSICAL
- 2 PARTICIPATION IN AN ATHLETIC ACTIVITY DUE TO A SUSPECTED CONCUSSION
- 3 AND HIS OR HER RETURN TO THAT ATHLETIC ACTIVITY.
- 4 (C) THE RISKS TO AN ATHLETE OF NOT REPORTING A SUSPECTED
- 5 CONCUSSION AND CONTINUING TO PHYSICALLY PARTICIPATE IN THE ATHLETIC
- 6 ACTIVITY.
- 7 (3) AS SOON AS THEY ARE AVAILABLE, THE DEPARTMENT SHALL MAKE
- 8 THE EDUCATIONAL MATERIALS AND TRAINING PROGRAM REQUIRED UNDER THIS
- 9 SECTION AVAILABLE TO THE PUBLIC ON THE DEPARTMENT'S INTERNET
- 10 WEBSITE.
- 11 (4) BEFORE THE EXPIRATION OF 1 YEAR AFTER THE EFFECTIVE DATE
- 12 OF THIS SECTION, THE DEPARTMENT SHALL PROMULGATE RULES UNDER THE
- 13 ADMINISTRATIVE PROCEDURES ACT OF 1969 THAT IT DETERMINES NECESSARY
- 14 TO IMPLEMENT AND ADMINISTER THIS SECTION. THE DEPARTMENT SHALL
- 15 IDENTIFY IN THE RULES IT PROMULGATES UNDER THIS SECTION THE
- 16 INDIVIDUALS WHO ARE REQUIRED TO PARTICIPATE IN THE TRAINING PROGRAM
- 17 DEVELOPED UNDER SUBSECTION (2). THE DEPARTMENT SHALL IDENTIFY IN
- 18 THE RULES PROMULGATED UNDER THIS SECTION THE ORGANIZING ENTITIES
- 19 AND ATHLETIC ACTIVITIES THAT ARE EXEMPT FROM THE APPLICATION OF
- 20 THIS SECTION PURSUANT TO SUBSECTION (7).
- 21 (5) BEFORE A YOUTH ATHLETE MAY PARTICIPATE IN AN ATHLETIC
- 22 ACTIVITY SPONSORED BY OR OPERATED UNDER THE AUSPICES OF AN
- 23 ORGANIZING ENTITY, THE ORGANIZING ENTITY SHALL DO ALL OF THE
- 24 FOLLOWING:
- 25 (A) COMPLY WITH ALL THE REQUIREMENTS OF THIS SECTION AND RULES
- 26 PROMULGATED UNDER THIS SECTION WITH REGARD TO ITS COACHES,
- 27 EMPLOYEES, VOLUNTEERS, AND OTHER ADULTS WHO ARE INVOLVED WITH THE

- 1 PARTICIPATION OF YOUTH ATHLETES IN ATHLETIC ACTIVITY SPONSORED BY
- 2 OR OPERATED UNDER THE AUSPICES OF THAT ORGANIZING ENTITY AND WHO
- 3 ARE REQUIRED TO PARTICIPATE IN THE CONCUSSION AWARENESS TRAINING
- 4 PROGRAM DEVELOPED UNDER SUBSECTION (2).
- 5 (B) PROVIDE THE EDUCATIONAL MATERIALS DEVELOPED UNDER
- 6 SUBSECTION (1) TO EACH YOUTH ATHLETE WHO PARTICIPATES IN AN
- 7 ATHLETIC ACTIVITY SPONSORED BY OR OPERATED UNDER THE AUSPICES OF
- 8 THE ORGANIZING ENTITY AND A PARENT OR GUARDIAN OF THE YOUTH
- 9 ATHLETE.
- 10 (C) OBTAIN AND MAINTAIN IN A PERMANENT FILE FOR THE DURATION
- 11 OF THAT YOUTH ATHLETE'S PARTICIPATION IN ATHLETIC ACTIVITY
- 12 SPONSORED BY OR OPERATED UNDER THE AUSPICES OF THAT ORGANIZING
- 13 ENTITY A STATEMENT SIGNED BY EACH YOUTH ATHLETE AND A PARENT OR
- 14 GUARDIAN OF THE YOUTH ATHLETE ACKNOWLEDGING RECEIPT OF THE
- 15 EDUCATIONAL MATERIAL DEVELOPED UNDER SUBSECTION (1). UPON REQUEST,
- 16 THE ORGANIZING ENTITY SHALL MAKE THE STATEMENTS OBTAINED UNDER THIS
- 17 SUBDIVISION AVAILABLE TO THE DEPARTMENT.
- 18 (6) A COACH OR OTHER ADULT EMPLOYED BY, VOLUNTEERING FOR, OR
- 19 OTHERWISE ACTING ON BEHALF OF AN ORGANIZING ENTITY DURING AN
- 20 ATHLETIC EVENT SPONSORED BY OR OPERATED UNDER THE AUSPICES OF THE
- 21 ORGANIZING ENTITY SHALL IMMEDIATELY REMOVE FROM PHYSICAL
- 22 PARTICIPATION IN AN ATHLETIC ACTIVITY A YOUTH ATHLETE WHO IS
- 23 SUSPECTED OF SUSTAINING A CONCUSSION DURING THE ATHLETIC ACTIVITY.
- 24 A YOUTH ATHLETE WHO HAS BEEN REMOVED FROM PHYSICAL PARTICIPATION IN
- 25 AN ATHLETIC ACTIVITY UNDER THIS SUBSECTION SHALL NOT RETURN TO
- 26 PHYSICAL PARTICIPATION IN THE ATHLETIC ACTIVITY UNTIL HE OR SHE HAS
- 27 BEEN EVALUATED BY A QUALIFIED LICENSED HEALTH PROFESSIONAL AND

- 1 RECEIVES WRITTEN CLEARANCE FROM THAT HEALTH PROFESSIONAL
- 2 AUTHORIZING THE YOUTH ATHLETE'S RETURN TO PHYSICAL PARTICIPATION IN
- 3 THE ATHLETIC ACTIVITY. THE ORGANIZING ENTITY SHALL MAINTAIN IN A
- 4 PERMANENT FILE FOR THE DURATION OF THAT YOUTH ATHLETE'S
- 5 PARTICIPATION IN ATHLETIC ACTIVITY SPONSORED BY OR OPERATED UNDER
- 6 THE AUSPICES OF THAT ORGANIZING ENTITY THE WRITTEN CLEARANCE UNDER
- 7 THIS SUBSECTION. UPON REQUEST, THE ORGANIZING ENTITY SHALL MAKE THE
- 8 WRITTEN CLEARANCE OBTAINED UNDER THIS SUBSECTION AVAILABLE TO THE
- 9 DEPARTMENT.
- 10 (7) THIS SECTION DOES NOT APPLY TO AN ATHLETIC ACTIVITY
- 11 SPONSORED BY OR OPERATED UNDER THE AUSPICES OF AN ORGANIZING ENTITY
- 12 IF ALL OF THE FOLLOWING REQUIREMENTS ARE MET:
- 13 (A) THE ENTITY IS A MEMBER OF A PRIVATE NONPROFIT MULTISPORT
- 14 STATEWIDE INTERSCHOLASTIC ATHLETIC ASSOCIATION OR OTHER SPORTS
- 15 ORGANIZATION.
- 16 (B) THE ATHLETIC ACTIVITY IS GOVERNED BY A RULE ESTABLISHED BY
- 17 THE INTERSCHOLASTIC ATHLETIC ASSOCIATION OR SPORTS ORGANIZATION
- 18 DESCRIBED IN SUBDIVISION (A), WHICH RULE ESTABLISHES CONCUSSION
- 19 PROTOCOLS THAT ARE SUBSTANTIALLY SIMILAR TO OR MORE STRINGENT THAN
- 20 THE CONCUSSION PROTOCOLS PROVIDED IN THIS SECTION AND INCLUDES AN
- 21 ENFORCEMENT MECHANISM ON ITS MEMBERS.
- 22 (8) AS USED IN THIS SECTION:
- 23 (A) "ATHLETIC ACTIVITY" MEANS A PROGRAM OR EVENT, INCLUDING
- 24 PRACTICE AND COMPETITION, DURING WHICH YOUTH ATHLETES PARTICIPATE
- 25 OR PRACTICE TO PARTICIPATE IN AN ORGANIZED ATHLETIC GAME OR
- 26 COMPETITION AGAINST ANOTHER TEAM, CLUB, ENTITY, OR INDIVIDUAL.
- 27 ATHLETIC ACTIVITY INCLUDES PARTICIPATION IN PHYSICAL EDUCATION

- 1 CLASSES THAT ARE PART OF A SCHOOL CURRICULUM.
- 2 (B) "CONCUSSION" MEANS A TRAUMATIC INJURY TO THE BRAIN CAUSING
- 3 A CHANGE IN A PERSON'S MENTAL STATUS AT THE TIME OF THE INJURY,
- 4 SUCH AS FEELING DAZED, DISORIENTED, OR CONFUSED, WHICH MAY OR MAY
- 5 NOT INVOLVE A LOSS OF CONSCIOUSNESS, RESULTING FROM ANY OF THE
- 6 FOLLOWING:
- 7 (i) A FALL.
- 8 (ii) A BLOW OR JOLT TO THE HEAD OR BODY.
- 9 (iii) THE SHAKING OR SPINNING OF THE HEAD OR BODY.
- 10 (iv) THE ACCELERATION AND DECELERATION OF THE HEAD.
- 11 (C) "ORGANIZING ENTITY" MEANS ANY OF THE FOLLOWING:
- 12 (i) A SCHOOL.
- 13 (ii) A STATE OR LOCAL PARKS AND RECREATION DEPARTMENT OR
- 14 COMMISSION OR OTHER STATE OR LOCAL ENTITY.
- 15 (iii) A NONPROFIT OR FOR-PROFIT ENTITY.
- 16 (iv) A PUBLIC OR PRIVATE ENTITY.
- 17 (D) "SCHOOL" MEANS A NONPUBLIC SCHOOL, PUBLIC SCHOOL, OR
- 18 PUBLIC SCHOOL ACADEMY AS THOSE TERMS ARE DEFINED IN SECTION 5 OF
- 19 THE REVISED SCHOOL CODE, 1976 PA 451, MCL 380.5.
- 20 (E) "YOUTH ATHLETE" MEANS AN INDIVIDUAL WHO ENGAGES IN AN
- 21 ATHLETIC ACTIVITY AND WHO IS UNDER 18 YEARS OF AGE.
