HOUSE BILL No. 4311

February 22, 2011, Introduced by Reps. Opsommer and Denby and referred to the Committee on Local, Intergovernmental, and Regional Affairs.

A bill to amend 1967 (Ex Sess) PA 8, entitled

"An act to provide for intergovernmental transfers of functions and responsibilities,"

by amending section 4 (MCL 124.534).

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 4. A contract shall include:
- 2 (a) A description of the functions or responsibilities to be
- 3 transferred.
 - (b) The effective date of the contract.
 - (c) The term of operation under the contract.
 - (d) The manner in which the affected employees, if any, of the participating political subdivisions shall be transferred,
 - reassigned, or otherwise treated. subject to the following:
 - (i) Such employees as are necessary for the operation thereof

shall be transferred to and appointed as employees subject to all

- 1 rights and benefits. These employees shall be given seniority
- 2 credits and sick leave, vacation, insurance and pension credits in
- 3 accordance with the records or labor agreements from the acquired
- 4 system. Members and beneficiaries of any pension or retirement
- 5 system or other benefits established by the acquired system shall
- 6 continue to have rights, privileges, benefits, obligations and
- 7 status with respect to such established system. The political
- 8 subdivision to which the functions or responsibilities have been
- 9 transferred shall assume the obligations of any system acquired by
- 10 it with regard to wages, salaries, hours, working conditions, sick
- 11 leave, health and welfare and pension or retirement provisions for
