A bill to amend 1998 PA 58, entitled "Michigan liquor control code of 1998,"

(MCL 436.1101 to 436.2303) by adding section 547.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 547. (1) AS USED IN THIS SECTION:
- 2 (A) "PRIVATE EVENT" MEANS AN EVENT WHERE NO CONSIDERATION, AS
  3 DEFINED IN SECTION 913(5), IS PAID BY THE GUESTS.
  - (B) "CATERING PERMIT" MEANS A PERMIT ISSUED BY THE COMMISSION
- 5 TO A HOLDER OF A PUBLIC ON-PREMISES LICENSE FOR THE SALE OF BEER,
- WINE, OR SPIRITS, OR ANY COMBINATION THEREOF, AND THAT IS ALSO
- 7 LICENSED AS A FOOD SERVICE ESTABLISHMENT UNDER THE FOOD LAW OF
- 8 2000, 2000 PA 92, MCL 289.1101 TO 289.8111, WHICH PERMIT AUTHORIZES

- 1 THE PERMIT HOLDER TO SELL AND DELIVER BEER, WINE, AND SPIRITS IN
- 2 THE ORIGINAL SEALED CONTAINER TO A PERSON FOR OFF-PREMISES
- 3 CONSUMPTION BUT ONLY IF THE SALE IS NOT BY THE GLASS OR DRINK AND

- 22 (5) NOTWITHSTANDING SUBSECTION (2), THIS SECTION DOES NOT
- 23 PROHIBIT A HOLDER OF A CATERING PERMIT FROM SELLING BEER, WINE, OR
- 24 SPIRITS TO A PERSON WHO HAS OBTAINED A SPECIAL LICENSE UNDER

- 26 (6) AN APPLICANT FOR A CATERING PERMIT SHALL APPLY ON A FORM
- 27 APPROVED AND PROVIDED BY THE COMMISSION AND PAY AN APPLICATION AND

- 1 PROCESSING FEE OF \$70.00 AND A CATERING PERMIT FEE OF \$100.00 AT
- 2 THE TIME OF ISSUANCE. THE ON-PREMISES LICENSEE SHALL ALSO PAY THE
- 3 CATERING PERMIT FEE AT THE TIME OF RENEWAL OF THE ON-PREMISES
- 4 LICENSE.
- 5 (7) THE PERSON DELIVERING THE BEER, WINE, OR SPIRITS SHALL
- 6 VERIFY THAT THE PERSON ACCEPTING DELIVERY IS AT LEAST 21 YEARS OF
- 7 AGE. THE CATERING PERMIT HOLDER MAY UTILIZE A THIRD PARTY THAT

- 14 (8) THE CATERING PERMIT HOLDER PROVIDING THE SERVICE, OR AN
- 15 EMPLOYEE OF THE CATERING PERMIT HOLDER, MUST HAVE SUCCESSFULLY
- 16 COMPLETED A SERVER TRAINING PROGRAM APPROVED BY THE COMMISSION.
- 17 (9) THE CATERING PERMIT HOLDER DELIVERING THE BEER, WINE, OR
- 18 SPIRITS, OR AN EMPLOYEE OF THE PERMIT HOLDER, SHALL HAVE IN HIS OR
- 19 HER POSSESSION WHILE DELIVERING THE BEER, WINE, OR SPIRITS
- 20 DOCUMENTATION DEMONSTRATING THAT THE BEER, WINE, OR SPIRITS BEING
