A bill to amend 1931 PA 328, entitled "The Michigan penal code,"

(MCL 750.1 to 750.568) by adding section 286.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 286. (1) A PERSON SHALL NOT MISREPRESENT HIS OR HER

- 6 (A) THAT HE OR SHE IS ENTITLED TO WEAR MILITARY AWARDS,
- 7 MILITARY DECORATIONS, OR MILITARY RANK.
- 8 (B) THAT HE OR SHE SERVED IN THE UNITED STATES ARMED FORCES, A
- RESERVE COMPONENT OF THE UNITED STATES ARMED FORCES, OR THE

- 2 (C) THAT HE OR SHE SERVED IN THE MILITARY DURING A WARTIME

- 5 (D) THAT HE OR SHE SERVED, OR IS SERVING, IN THE MILITARY AT A
- 6 CERTAIN LOCATION, WITH A CERTAIN RANK OR RATING, OR ENGAGED IN A
- 7 CERTAIN MISSION, OR ANY OTHER CLAIM CONCERNING HIS OR HER ACTUAL

- 14 THE NATIONAL GUARD IN A PLAY, MOTION PICTURE, TELEVISION
- 15 PRODUCTION, OR OTHER DRAMATIC PRODUCTION, OR AT A PATRIOTIC OR

- 17 (C) SERVES AS A MEMBER OF THE UNITED STATES ARMED FORCES, A
- 18 RESERVE COMPONENT OF THE UNITED STATES ARMED FORCES, OR THE
- 19 NATIONAL GUARD AND, AS PART OF A MILITARY ASSIGNMENT, IS
- 20 REPRESENTING A MEMBER OF THE UNITED STATES ARMED FORCES IN A

- 22 PURPOSES.
- 23 (D) WORKS AS AN EMPLOYEE OF OR VOLUNTEER FOR A MUSEUM AND, AS
- 24 A PART OF HIS OR HER DUTIES, IS REPRESENTING A MEMBER OF THE UNITED
- 25 STATES ARMED FORCES, A RESERVE COMPONENT OF THE UNITED STATES ARMED
- 26 FORCES, OR THE NATIONAL GUARD FOR CEREMONIAL, HISTORICAL, OR
- 27 TRAINING PURPOSES.

- 1 (E) OWNS, DISPLAYS, PURCHASES, SELLS, OR TRADES MILITARIA,
- 2 INCLUDING, BUT NOT LIMITED TO, MEDALS, RIBBONS, AND RANK INSIGNIA,
- 3 AND DOES NOT CLAIM TO HAVE PERSONALLY EARNED THEM UNLESS HE OR SHE
- 4 IS LEGALLY ENTITLED TO DO SO.
- 5 (F) USES HIS OR HER GIVEN NAME THAT INCLUDES A MILITARY RANK,
- 6 SO LONG AS HE OR SHE DOES NOT USE THE NAME TO DEFRAUD ANOTHER IN A
- 7 MANNER PROHIBITED BY THIS SECTION.
- 8 (G) USES A NAME OR HONORARY MILITARY OR MILITARY-LIKE RANK
- 9 THAT HAS BEEN BESTOWED UPON HIM OR HER BY A PUBLIC OFFICER, PUBLIC
- 10 EMPLOYEE, OR PUBLIC AGENCY, IN THE NAME OF A PUBLIC OFFICER OR
- 11 PUBLIC AGENCY.
- 12 (H) USES A CORPORATE, PARTNERSHIP, SOLE PROPRIETORSHIP, OR
- 13 OTHER NAME FOR A BUSINESS OR PRODUCT THAT INCLUDES A MILITARY RANK,
- 14 SO LONG AS THE NAME IS NOT USED TO DEFRAUD ANOTHER IN A MANNER
- 15 PROHIBITED BY THIS SECTION.
- 16 (I) HOLDS A REGISTERED TRADEMARK THAT INCLUDES A MILITARY RANK
- 17 OR HONORARY RANK, SO LONG AS THE TRADEMARK IS NOT USED TO DEFRAUD
- 18 ANOTHER IN A MANNER PROHIBITED BY THIS SECTION.
- 19 (3) A PERSON WHO VIOLATES THIS SECTION IS GUILTY OF A
- 20 MISDEMEANOR PUNISHABLE BY IMPRISONMENT FOR NOT MORE THAN 1 YEAR, A
- 21 FINE OF NOT MORE THAN \$5,000.00, OR BOTH, AND NOT MORE THAN 100
- 22 HOURS OF COMMUNITY SERVICE, THAT SHALL BE PERFORMED IN A VETERANS
- 23 HOME OR FOR A VETERANS SERVICE ORGANIZATION.
- 24 (4) A PERSON MAY BE CHARGED WITH, CONVICTED OF, AND SENTENCED
- 25 FOR ANY OTHER VIOLATION OF LAW IN ADDITION TO THE VIOLATION OF THIS
- 26 SECTION.
- 27 (5) THIS SECTION SHALL BE KNOWN AND MAY BE CITED AS THE
