HOUSE BILL No. 5100

October 19, 2011, Introduced by Rep. Hobbs and referred to the Committee on Education.

A bill to amend 1976 PA 451, entitled "The revised school code,"

by amending sections 504a, 525, and 557 (MCL 380.504a, 380.525, and 380.557), section 504a as amended and section 525 as added by 2003 PA 179 and section 557 as added by 2009 PA 205, and by adding section 1280d.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 504a. In addition to other powers set forth in this part, a public school academy may take action to carry out the purposes for which it was incorporated under this part, including, but not limited to, all of the following:
 - (a) To sue and be sued in its name.
 - (b) Subject to section 503b, to acquire, hold, and own in its own name real and personal property, or interests in real or

- 2 grant, devise, bequest, lease, sublease, installment purchase
- 3 agreement, land contract, option, or condemnation, and subject to
- 4 mortgages, security interests, or other liens; and to sell or

- 12 mortgages, security interests, or other liens; and to sell or

- 20 mortgages, security interests, or other liens; and to sell or

- 16 SEC. 1280D. (1) IF AN EDUCATIONAL MANAGEMENT ORGANIZATION IS A
- 17 PARTY TO A MANAGEMENT AGREEMENT WITH 1 OR MORE PUBLIC SCHOOLS ON
- 18 THE LIST UNDER SECTION 1280C(1) OF THE PUBLIC SCHOOLS IN THIS STATE
- 19 THAT THE DEPARTMENT HAS DETERMINED TO BE AMONG THE LOWEST ACHIEVING
- 20 5% OF ALL PUBLIC SCHOOLS IN THIS STATE, THE BOARD OF A SCHOOL
- 21 DISTRICT OR BOARD OF DIRECTORS OF A PUBLIC SCHOOL ACADEMY SHALL NOT
- 22 ENTER INTO A MANAGEMENT AGREEMENT WITH THE EDUCATIONAL MANAGEMENT
- 23 ORGANIZATION. THE DEPARTMENT SHALL COMPILE AND ANNUALLY UPDATE A
- 24 LIST OF EDUCATIONAL MANAGEMENT ORGANIZATIONS DESCRIBED IN THIS
- 25 SECTION AND POST THAT LIST ON ITS WEBSITE.
- 26 (2) AS USED IN THIS SECTION:
- 27 (A) "EDUCATIONAL MANAGEMENT ORGANIZATION" MEANS AN ENTITY THAT

- 1 ENTERS INTO A MANAGEMENT AGREEMENT WITH THE GOVERNING BOARD OF A
- 2 PUBLIC SCHOOL.
- 3 (B) "ENTITY" MEANS A PARTNERSHIP, NONPROFIT OR BUSINESS
- 4 CORPORATION, OR ANY OTHER ASSOCIATION, CORPORATION, TRUST, OR OTHER
- 5 LEGAL ENTITY.
- 6 (C) "MANAGEMENT AGREEMENT" MEANS AN AGREEMENT TO PROVIDE
- 7 COMPREHENSIVE EDUCATIONAL, ADMINISTRATIVE, MANAGEMENT, OR
- 8 INSTRUCTIONAL SERVICES OR STAFF TO A PUBLIC SCHOOL.
