THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 17015A. (1) IF A PATIENT SCHEDULES AN APPOINTMENT FOR AN
- 2 ABORTION AFTER RECEIVING THE INFORMATION REQUIRED UNDER SECTION
- 3 17015(3), THE PHYSICIAN OR QUALIFIED PERSON ASSISTING THE PHYSICIAN
- 4 SHALL ORALLY SCREEN THE PATIENT FOR COERCION TO ABORT AND DOMESTIC
- 5 VIOLENCE USING THE SCREENING TOOLS DEVELOPED BY THE DEPARTMENT
- 6 UNDER SECTION 17015(11).
- 7 (2) IF A PATIENT DISCLOSES THAT SHE IS THE VICTIM OF DOMESTIC
 - VIOLENCE THAT DOES NOT INCLUDE COERCION TO ABORT, THE PHYSICIAN OR
 - QUALIFIED PERSON ASSISTING THE PHYSICIAN SHALL FOLLOW THE PROTOCOLS

- 4 (7) THIS SECTION DOES NOT CREATE A RIGHT TO ABORTION.
- 5 NOTWITHSTANDING ANY OTHER PROVISION OF THIS SECTION, A PERSON SHALL

- 7 Sec. 17515. A physician, before performing an abortion on a
