A bill to amend 1977 PA 89, entitled "State aid to public libraries act," by amending section 17 (MCL 397.567), as amended by 2001 PA 65.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 17. (1) A-EXCEPT AS OTHERWISE PROVIDED IN THIS SECTION, A
- 2 cooperative library and public library shall conform to
- 3 certification requirements for personnel as established by the
- 4 department in order to qualify for state aid.
- 5 (2) A VOLUNTEER PUBLIC LIBRARY MAY RECEIVE STATE AID WITHOUT
- 6 MEETING THE OPERATIONAL STANDARDS OTHERWISE REQUIRED OF A PUBLIC
- 7 LIBRARY TO RECEIVE STATE AID. HOWEVER, ANNUAL STATE AID TO A
- 8 VOLUNTEER PUBLIC LIBRARY SHALL NOT EXCEED AN AMOUNT EQUAL TO THE
- 9 SUM OF ALL OF THE FOLLOWING IN THE IMMEDIATELY PRECEDING YEAR:
  - (A) APPROPRIATIONS RECEIVED FROM THE LOCAL UNIT OF GOVERNMENT.

- 1 (B) THE MONETARY DONATIONS THE PUBLIC LIBRARY RECEIVED THROUGH
- 2 GIFTS AND FUND-RAISING.
- 3 (C) THE VALUE OF IN-KIND CONTRIBUTIONS SUCH AS SERVICES,
- 4 GOODS, AND SUPPLIES. FOR PURPOSES OF THIS SUBDIVISION, IN-KIND
- 5 VOLUNTEER STAFFING SERVICES SHALL BE VALUED AT THE MINIMUM WAGE

- 8 (3) AS USED IN THIS SECTION, "VOLUNTEER PUBLIC LIBRARY" MEANS
- 9 A PUBLIC LIBRARY THAT MEETS ALL OF THE FOLLOWING CRITERIA:
- 10 (A) IS ESTABLISHED UNDER SECTION 13A OF THE CHARTER TOWNSHIP
- 11 ACT, 1947 PA 359, MCL 42.13A.
- 12 (B) HAS UNPAID VOLUNTEERS AS A MAJORITY OF THE LIBRARY STAFF.
- 13 (C) HAS A CERTIFIED LIBRARIAN ON ITS LIBRARY ADVISORY BOARD OR
- 14 ON THE LIBRARY STAFF.
- 15 (D) IS OPEN TO THE PUBLIC FOR AN AVERAGE OF 20 OR MORE HOURS
- 16 EACH WEEK.
