## **HOUSE BILL No. 5230**

December 14, 2011, Introduced by Reps. Barnett and Wayne Schmidt and referred to the Committee on Regulatory Reform.

A bill to amend 1919 PA 339, entitled "Dog law of 1919,"

(MCL 287.261 to 287.290) by adding section 10a.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 10A. (1) A PERSON WHO OPERATES A LARGE-SCALE COMMERCIAL
- 2 BREEDING KENNEL SHALL APPLY ANNUALLY TO THE DEPARTMENT FOR A LARGE-
- 3 SCALE COMMERCIAL BREEDING KENNEL LICENSE. IN ADDITION, THE
- 4 APPLICANT FOR A LARGE-SCALE COMMERCIAL BREEDING KENNEL LICENSE
- 5 SHALL PAY AN ANNUAL \$500.00 SITE INSPECTION FEE TO THE DEPARTMENT.
- 6 (2) BEFORE ISSUING A LARGE-SCALE COMMERCIAL BREEDING KENNEL
  - LICENSE, THE DEPARTMENT SHALL INSPECT THE KENNEL TO VERIFY THAT THE
  - KENNEL COMPLIES WITH ALL OF THE PROVISIONS CONCERNING LARGE-SCALE
- 9 COMMERCIAL BREEDING KENNELS AS PROVIDED IN THE PUPPY PROTECTION
- 10 ACT. THE DEPARTMENT MAY DELEGATE THE INSPECTION REQUIRED UNDER THIS

- 1 SUBSECTION TO A COUNTY ANIMAL CONTROL AGENCY. IF THE DEPARTMENT

- 22 Enacting section 1. This amendatory act takes effect January
