

HOUSE BILL No. 5282

January 24, 2012, Introduced by Rep. Rendon and referred to the Committee on Judiciary.

A bill to amend 1931 PA 328, entitled
"The Michigan penal code,"
by amending section 231a (MCL 750.231a), as amended by 2008 PA 196.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 231a. (1) Subsection (2) of section 227 does not apply to
2 any of the following:

3 (a) To a person holding a valid license to carry a pistol
4 concealed upon his or her person issued by his or her state of
5 residence except where the pistol is carried in nonconformance with
6 a restriction appearing on the license.

7 (b) To the regular and ordinary transportation of pistols as
8 merchandise by an authorized agent of a person licensed to
9 manufacture firearms.

10 (c) To a person carrying an antique firearm, ~~as defined in~~

1 ~~subsection (2),~~ completely unloaded in a closed case or container
2 designed for the storage of firearms in the trunk of a vehicle.

3 (d) To a person while transporting a pistol for a lawful
4 purpose that is licensed by the owner or occupant of the motor
5 vehicle in compliance with section 2 of 1927 PA 372, MCL 28.422,
6 and the pistol is unloaded in a closed case designed for the
7 storage of firearms in the trunk of the vehicle.

8 (e) To a person while transporting a pistol for a lawful
9 purpose that is licensed by the owner or occupant of the motor
10 vehicle in compliance with section 2 of 1927 PA 372, MCL 28.422,
11 and the pistol is unloaded in a closed case designed for the
12 storage of firearms in a vehicle that does not have a trunk and is
13 not readily accessible to the occupants of the vehicle.

14 (2) As used in this section, +

15 ~~— (a) "Antique"~~ **"ANTIQUE"** firearm" means either of the following:

16 (i) A firearm not designed or redesigned for using rimfire or
17 conventional center fire ignition with fixed ammunition and
18 manufactured in or before 1898, including a matchlock, flintlock,
19 percussion cap, or similar type of ignition system or replica of
20 such a firearm, whether actually manufactured before or after 1898.

21 (ii) A firearm using fixed ammunition manufactured in or before
22 1898, for which ammunition is no longer manufactured in the United
23 States and is not readily available in the ordinary channels of
24 commercial trade.

26 ~~— (i) While en route to or from a hunting or target shooting~~

~~1 (ii) While transporting a pistol en route to or from his or her~~
~~2 home or place of business and place of repair.~~

~~3 (iii) While moving goods from 1 place of abode or business to~~
~~4 another place of abode or business.~~

~~5 (iv) While transporting a licensed pistol en route to or from a~~
~~6 law enforcement agency or for the purpose of having a law~~
~~7 enforcement official take possession of the weapon.~~

~~8 (v) While en route to or from his or her abode or place of~~
~~9 business and a gun show or places of purchase or sale.~~

~~10 (vi) While en route to or from his or her abode to a public~~
~~11 shooting facility or public land where discharge of firearms is~~
~~12 permitted by law, rule, regulation, or local ordinance.~~

~~13 (vii) While en route to or from his or her abode to a private~~
~~14 property location where the pistol is to be used as is permitted by~~
~~15 law, rule, regulation, or local ordinance.~~
