- 3 THIS ACT SHALL SUBMIT A WRITTEN APPLICATION TO THE BUREAU ON A FORM
- 4 PRESCRIBED BY RULES PROMULGATED UNDER THIS ACT.
- 5 (2) IF THE COMMISSIONER DETERMINES THAT AN APPLICANT IS
- 6 ELIGIBLE AND HAS PAID THE ANNUAL FEE PRESCRIBED BY SUBSECTION (4),
- 7 THE BUREAU MAY ISSUE A MILLIONAIRE PARTY VENUE LICENSE TO ALLOW
- 8 MILLIONAIRE PARTIES TO BE CONDUCTED BY MILLIONAIRE PARTY LICENSEES
- 9 ON PROPERTY OWNED OR LEASED BY THE APPLICANT.
- 10 (3) A MILLIONAIRE PARTY VENUE LICENSE EXPIRES AT 12 MIDNIGHT
 - ON THE LAST DAY OF FEBRUARY OF THE CALENDAR YEAR AFTER THE LICENSE
