## **HOUSE BILL No. 5494**

March 20, 2012, Introduced by Reps. Ananich, Tlaib, Stanley, Smiley, Irwin, Liss, Kandrevas, Bauer and Rutledge and referred to the Committee on Regulatory Reform.

A bill to amend 1917 PA 350, entitled

"An act to regulate and license second hand dealers and junk dealers; and to prescribe penalties for the violation of the provisions of this act,"

by amending sections 1 and 3 (MCL 445.401 and 445.403), section 1 as amended by 2008 PA 432 and section 3 as amended by 2006 PA 675.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 1. (1) A person, corporation, copartnership, EXCEPT AS
- 2 OTHERWISE PROVIDED IN THIS SECTION, AN INDIVIDUAL or firm shall not
- 3 carry on the business of dealer in A second hand goods DEALER or
- 4 junk dealer in any of the counties, cities, or villages of A
- 5 COUNTY, CITY, OR VILLAGE IN this state without having first
- 6 obtained, OBTAINING A LICENSE THAT AUTHORIZES THE INDIVIDUAL OR
- 7 FIRM TO CARRY ON THAT BUSINESS from the mayor of the city or the
- 8 chief executive officer of the county or village. where the
- 9 business is to be carried on, a license under this act authorizing

- 1 that person, corporation, copartnership, or firm to carry on that
- 2 business.
- 3 (2) This section does not require an internet drop-off store
- 4 complying with subsection (3), or a person AN INDIVIDUAL engaged in
- 5 the sale, purchase, consignment, or trade of personal property or
- 6 other valuable thing AN ITEM for himself or herself , to IS NOT
- 7 REQUIRED TO obtain a license under this act.
- 8 (3) An internet drop-off store in compliance with THAT MEETS
- 9 ALL OF the following conditions is exempt from licensure as a
- 10 second hand dealer or junk dealer NOT REQUIRED TO OBTAIN A LICENSE
- 11 under this act:
- 12 (a) Has a fixed place of business within IN this state, except
- 13 that he or she exclusively transacts AND all purchases or sales OF
- 14 ITEMS ARE EXCLUSIVELY TRANSACTED by means of the internet and the
- 15 purchases and sales are not physically transacted on the premises
- 16 of that fixed place of business.
- 17 (b) Has the personal property or other valuable thing AN ITEM
- 18 IT OFFERS available on a website for viewing by photograph, if
- 19 available, by the general public at no charge, which AND THE
- 20 website shall be IS searchable by zip code, or state, or both. The
- 21 website viewing shall include, MUST ALSO DISPLAY, as applicable,
- 22 ANY serial number, make, model, and other unique identifying marks,
- 23 numbers, names, or letters appearing THAT APPEAR on the personal
- 24 property or other valuable thing. ITEM.
- 25 (c) Maintains records of the sale, purchase, consignment, or
- 26 trade of the personal property or other valuable thing AN ITEM IT
- 27 OFFERS for at least 2 years. , which records shall THE RECORDS MUST

- 1 contain a description, including a photograph, if available, and,
- 2 if applicable, serial number, make, model, and other unique
- 3 identifying marks, numbers, names, or letters appearing on the
- 4 personal property or other valuable thing. ITEM.
- 5 (d) Provide—PROVIDES the local law enforcement agency with any
- 6 name under which it conducts business on the website and access to
- 7 the business premises at any time during normal business hours for
- 8 purposes of inspection.
- 9 (e) Within 24 hours after a request from a local law
- 10 enforcement agency CONCERNING AN ITEM IT OFFERS OR OFFERED, provide
- 11 PROVIDES an electronic copy of the seller's or consignor's name,
- 12 address, telephone number, AND driver license number and issuing
- 13 state; —the buyer's name and address, if applicable; —and a
- 14 description of the personal property or other valuable thing as
- 15 ITEM THAT INCLUDES THE INFORMATION described in subdivision (c).
- 16 The provision of STORE SHALL PROVIDE THE information shall be in a
- 17 format acceptable to the local law enforcement agency but shall at
- 18 least be in a legible format and in the English language.
- 19 (f) Provide PROVIDES that payment for the personal property or
- 20 other valuable thing is executed AN ITEM IT OFFERS IS MADE by means
- 21 of A check or other electronic payment system , so long as the
- 22 payment AND is not made in cash. No payment shall be provided to
- 23 the A STORE SHALL NOT PAY A seller FOR AN ITEM until the item is
- 24 sold.
- 25 (g) Immediately remove the personal property or other valuable
- 26 thing REMOVES AN ITEM IT OFFERS from the website if the local law
- 27 enforcement agency determines that the personal property or other

- 1 valuable thing ITEM is stolen.
- 2 (4) AN INDIVIDUAL OR FIRM IS NOT REQUIRED TO OBTAIN A LICENSE
- 3 FROM A CITY, COUNTY, OR VILLAGE UNDER THIS ACT IF ALL OF THE
- 4 FOLLOWING ARE MET:
- 5 (A) THE INDIVIDUAL'S OR FIRM'S BUSINESS AS A SECOND HAND
- 6 DEALER OR JUNK DEALER IN THE CITY, COUNTY, OR VILLAGE IS ACTING AS
- 7 A SCRAP METAL DEALER.
- 8 (B) THE INDIVIDUAL OR FIRM IS LICENSED AS A SCRAP METAL DEALER
- 9 UNDER THE SCRAP METAL LICENSING ACT.
- 10 (C) THE CITY, COUNTY, OR VILLAGE ELECTS TO EXEMPT SCRAP METAL
- 11 DEALERS FROM THE OBLIGATION TO OBTAIN A LICENSE AS A SECOND HAND
- 12 DEALER OR JUNK DEALER.
- 13 (5) (4) This section does not exempt a person purchasing or
- 14 selling articles of nonferrous metals from compliance with AN
- 15 INDIVIDUAL OR FIRM ENGAGED IN PURCHASING OR SELLING SCRAP METAL
- 16 FROM COMPLYING WITH THE SCRAP METAL LICENSING ACT OR the nonferrous
- 17 metal regulatory act.
- 18 Sec. 3. As used in this act:
- 19 (a) "Automotive recycler" means a person who AN INDIVIDUAL OR
- 20 FIRM THAT engages in business primarily for the purpose of selling
- 21 retail salvage vehicle parts and secondarily for the purpose of
- 22 selling retail salvage motor vehicles or manufacturing or selling a
- 23 product of gradable scrap metal; or a person AN INDIVIDUAL employed
- 24 as a salvage vehicle agent as that term is defined in section 56c
- 25 of the Michigan vehicle code, 1949 PA 300, MCL 257.56c.
- 26 (B) "FIRM" MEANS A CORPORATION, LIMITED LIABILITY COMPANY,
- 27 PARTNERSHIP, OR OTHER LEGAL ENTITY.

- 1 (C) (b) "Industrial scrap" means materials that are a direct
- 2 product or by-product of any form of manufacturing, shaping, or
- 3 cutting process from a person, company, corporation, copartnership,
- 4 AN INDIVIDUAL or firm whose principal business is the
- 5 manufacturing, shaping, or cutting of materials at a fixed place of
- 6 business.
- 7 (D) (c) "Internet drop-off store" means a person, corporation,
- 8 AN INDIVIDUAL or firm that contracts with other persons,
- 9 corporations, INDIVIDUALS or firms to offer its personal property
- 10 or other valuable thing AN ITEM for sale, purchase, consignment, or
- 11 trade through means of an internet website and meets the conditions
- 12 described in section 1(3).
- 13 (E) "ITEM" MEANS AN ITEM OF PERSONAL PROPERTY OR ANY OTHER
- 14 VALUABLE THING.
- (F) (d) "Local law enforcement agency" means the police agency
- 16 of the city, village, or township, or if none, the county sheriff
- 17 of the county in which the AN internet drop-off store conducts
- 18 business.
- 19 (G) "SCRAP METAL" MEANS THAT TERM AS DEFINED IN SECTION 3 OF
- 20 THE SCRAP METAL REGULATORY ACT, MCL 445.423.
- 21 (H) "SCRAP METAL DEALER" MEANS THAT TERM AS DEFINED IN SECTION
- 22 3 OF THE SCRAP METAL REGULATORY ACT, MCL 445.423.
- 23 (I) "SCRAP METAL REGULATORY ACT" MEANS THE SCRAP METAL
- 24 REGULATORY ACT, 2008 PA 429, MCL 445.421 TO 445.443.
- 25 (J) (e) "Scrap processor" means a person, utilizing AN
- 26 INDIVIDUAL OR FIRM THAT UTILIZES machinery and equipment, and
- 27 operating THAT OPERATES from a fixed location, AND whose principal

- 1 business is the processing and manufacturing of iron, steel,
- 2 nonferrous metals, paper, plastic, or glass, into prepared grades
- 3 of products suitable for consumption by recycling mills, foundries,
- 4 and OR other scrap processors.
- 5 (K) <del>(f)</del> "Second hand dealer" or "junk dealer" means <del>any</del>
- 6 person, corporation, or member or members of a copartnership AN
- 7 INDIVIDUAL or firm whose principal business is that of purchasing,
- 8 selling, exchanging, storing, or receiving second hand articles of
- 9 any kind, scrap metals, cast iron, old iron, old steel, tool steel,
- 10 aluminum, copper, brass, lead pipe or tools, or lighting and
- 11 plumbing fixtures. Second hand dealer or junk dealer does not
- 12 include a scrap processor, an automotive recycler, or a junkyard
- 13 that deals principally in industrial scrap and is licensed TO
- 14 CONDUCT THAT BUSINESS by a city, village, or county.
- 15 Enacting section 1. This amendatory act does not take effect
- 16 unless all of the following bills of the 96th Legislature are
- 17 enacted into law:
