THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 3A. (1) THE LEGISLATIVE BODY OF A CITY, TOWNSHIP, OR
- 2 VILLAGE MAY AUTHORIZE BY RESOLUTION THAT A STUDY BE CONDUCTED TO
- 3 REVIEW THE POTENTIAL SAVINGS AND EFFICIENCIES FROM ANY OF THE
- 4 FOLLOWING:
- 5 (A) CONSOLIDATING THAT CITY, TOWNSHIP, OR VILLAGE WITH 1 OR 6 MORE OTHER CITIES, TOWNSHIPS, OR VILLAGES.
 - (B) SHARING SERVICES OR PROGRAMS WITH 1 OR MORE OTHER CITIES, TOWNSHIPS, OR VILLAGES.
 - (2) THE LEGISLATIVE BODY OF A SCHOOL DISTRICT OR INTERMEDIATE
 SCHOOL DISTRICT MAY AUTHORIZE BY RESOLUTION THAT A STUDY BE
 CONDUCTED TO REVIEW THE POTENTIAL SAVINGS AND EFFICIENCIES FROM ANY

- 25 (B) "SCHOOL DISTRICT" MEANS THAT TERM AS DEFINED IN SECTION 6
