- 1 DETERMINES THAT 1 OR MORE OF THE FOLLOWING APPLY:
- 2 (A) THE PERSON IS RESEARCHING THE EFFECT OF A COAL TAR PRODUCT
- 3 ON THE ENVIRONMENT OR IS DEVELOPING AN ALTERNATIVE TECHNOLOGY, AND
- 4 THE USE OF THE COAL TAR PRODUCT IS REQUIRED FOR THE RESEARCH OR
- 5 DEVELOPMENT.
- 6 (B) A SUITABLE ALTERNATIVE TO THE COAL TAR PRODUCT IS NOT
- 7 AVAILABLE FOR THE USE INTENDED BY THE PERSON.
- 8 SEC. 14909. A PERSON WHO VIOLATES THIS PART IS RESPONSIBLE FOR
- 9 A STATE CIVIL INFRACTION AND MAY BE ORDERED TO PAY A CIVIL FINE OF
- 10 NOT MORE THAN \$1,000.00.
