SENATE BILL No. 104

February 8, 2011, Introduced by Senators KAHN, MARLEAU, PROOS, MEEKHOF, JONES, BRANDENBURG and BOOHER and referred to the Committee on Transportation.

A bill to amend 1949 PA 300, entitled "Michigan vehicle code,"

by amending section 811e (MCL 257.811e), as amended by 2009 PA 99, and by adding section 811r.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

Sec. 811e. (1) Beginning January 1, 2007, the THE secretary of state may develop a fund-raising plate as provided in this section.

(2) A start-up fee of \$15,000.00 shall be paid for any new fund-raising plate authorized under this section. The fee shall be deposited in the transportation administration collection fund through October 1, 2011 to be used for the cost of creating, producing, and issuing fund-raising plates. If the fee described in this subsection is not paid within 18 months of AFTER the effective date of the public act that authorizes the development and issuance

- 2 not be created, produced, or issued. A start-up fee paid under this

- 4 (3) Not less than 3 years after the secretary of state first

- 6 and upon payment of \$2,000.00, the Michigan university or other

- 2 SEC. 811R. (1) THE SECRETARY OF STATE SHALL DEVELOP UNDER

- 15 FROM THE SALE OF FUND-RAISING PLATES RECOGNIZING THE BOY SCOUTS OF
- 16 AMERICA TO THE STATE TREASURER, WHO SHALL CREDIT THE DONATION MONEY
- 17 TO THE BOY SCOUTS OF AMERICA FUND ESTABLISHED UNDER SUBSECTION (2).
- 18 (4) THE STATE TREASURER SHALL DISBURSE MONEY IN THE FUND
- 19 ESTABLISHED UNDER SUBSECTION (2) ON A QUARTERLY BASIS TO THE BOY
- 20 SCOUTS OF AMERICA. BEGINNING NOT LATER THAN FEBRUARY 1, 2012, THE
- 21 BOY SCOUTS OF AMERICA SHALL SUBMIT TO THE STATE TREASURER A SUMMARY
- 22 OF THE EXPENDITURES DURING THE PRECEDING YEAR OF THE MONEY RECEIVED
- 23 UNDER THIS SECTION.
