SENATE BILL No. 317

April 12, 2011, Introduced by Senator HUNE and referred to the Committee on Transportation.

A bill to amend 1949 PA 300, entitled "Michigan vehicle code,"

by amending section 811e (MCL 257.811e), as amended by 2009 PA 99, and by adding section 811r.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 811e. (1) Beginning January 1, 2007, the THE secretary of state may develop a fund-raising plate as provided in this section.
 - (2) A start-up fee of \$15,000.00 shall be paid for any new fund-raising plate authorized under this section. The fee shall be deposited in the transportation administration collection fund through October 1, 2011 to be used for the cost of creating, producing, and issuing fund-raising plates. If the fee described in this subsection is not paid within 18 months of—AFTER the effective date of the public act that authorizes the development and issuance

- 1 of a fund-raising plate, then the related fund-raising plate shall
- 2 not be created, produced, or issued. A start-up fee paid under this
- 3 subsection is nonrefundable.
- 4 (3) Not less than 3 years after the secretary of state first
- 5 issues 1 of the fund-raising plates as described in subsection (1)
- 6 and upon payment of \$2,000.00, the Michigan university or other
- 7 person sponsoring that fund-raising plate may redesign it as
- 8 approved by the secretary of state. The payment required under this
- 9 subsection shall be deposited in the transportation administration
- 10 collection fund through October 1, 2011 to be used for the cost of

- 2 SEC. 811R. (1) THE SECRETARY OF STATE SHALL DEVELOP UNDER
- 3 SECTION 811E AND ISSUE UNDER SECTION 811F A FUND-RAISING PLATE
- 4 RECOGNIZING THE MICHIGAN 4-H FOUNDATION. THE SECRETARY OF STATE IN
- 5 CONJUNCTION WITH THE MICHIGAN 4-H FOUNDATION SHALL DESIGN THE FUND-
- 6 RAISING PLATES AUTHORIZED IN THIS SECTION.
- 7 (2) THE MICHIGAN 4-H FOUNDATION FUND IS CREATED WITHIN THE
- 8 STATE TREASURY. THE STATE TREASURER MAY RECEIVE MONEY OR OTHER

- 13 SHALL REMAIN IN THE FUND AND SHALL NOT LAPSE TO THE GENERAL FUND.
- 14 (3) THE SECRETARY OF STATE SHALL TRANSFER THE DONATION MONEY
- 15 FROM THE SALE OF FUND-RAISING PLATES RECOGNIZING THE MICHIGAN 4-H
- 16 FOUNDATION TO THE STATE TREASURER, WHO SHALL CREDIT THE DONATION
- 17 MONEY TO THE MICHIGAN 4-H FOUNDATION FUND ESTABLISHED UNDER
- 18 SUBSECTION (2).
- 19 (4) THE STATE TREASURER SHALL DISBURSE MONEY IN THE FUND
- 20 ESTABLISHED UNDER SUBSECTION (2) ON A QUARTERLY BASIS TO THE
- 21 MICHIGAN 4-H FOUNDATION. BEGINNING NOT LATER THAN FEBRUARY 1, 2013,
- 22 THE MICHIGAN 4-H FOUNDATION SHALL SUBMIT TO THE STATE TREASURER A
- 23 SUMMARY OF THE EXPENDITURES DURING THE PRECEDING YEAR OF THE MONEY
- 24 RECEIVED UNDER THIS SECTION.
