A bill to amend 1980 PA 350, entitled "The nonprofit health care corporation reform act," (MCL 550.1101 to 550.1704) by adding section 416e.

- 1 SEC. 416E. (1) A HEALTH CARE CORPORATION GROUP OR NONGROUP
 2 CERTIFICATE SHALL PROVIDE COVERAGE FOR THE DIAGNOSIS AND TREATMENT
 3 OF AUTISM SPECTRUM DISORDERS.
 - (2) COVERAGE UNDER THIS SECTION IS NOT SUBJECT TO LIMITS ON THE NUMBER OF VISITS A MEMBER MAY USE FOR TREATMENT OF AUTISM SPECTRUM DISORDERS.
 - (3) COVERAGE UNDER THIS SECTION SHALL NOT BE DENIED OR LIMITED ON THE BASIS THAT IT IS EDUCATIONAL OR HABILITATIVE IN NATURE.
