A bill to amend 1956 PA 218, entitled "The insurance code of 1956,"

(MCL 500.100 to 500.8302) by adding section 3406s.

- 1 SEC. 3406S. (1) AN EXPENSE-INCURRED HOSPITAL, MEDICAL, OR
- 2 SURGICAL GROUP OR INDIVIDUAL POLICY OR CERTIFICATE DELIVERED,
- 3 ISSUED FOR DELIVERY, OR RENEWED IN THIS STATE AND A HEALTH
- 4 MAINTENANCE ORGANIZATION GROUP OR INDIVIDUAL CONTRACT SHALL PROVIDE
- 5 COVERAGE FOR THE DIAGNOSIS AND TREATMENT OF AUTISM SPECTRUM
- 6 DISORDERS. AN INSURER AND A HEALTH MAINTENANCE ORGANIZATION SHALL
- 7 NOT TERMINATE COVERAGE OR REFUSE TO DELIVER, EXECUTE, ISSUE, AMEND,
- 8 ADJUST, OR RENEW COVERAGE SOLELY BECAUSE AN INDIVIDUAL IS DIAGNOSED
- 9 WITH, OR HAS RECEIVED TREATMENT FOR, AN AUTISM SPECTRUM DISORDER.

- 19 (J) "TREATMENT PLAN" MEANS A WRITTEN COMPREHENSIVE EVALUATION
- 20 BY A MULTIDISCIPLINARY TEAM, INDIVIDUALIZED FOR EACH PATIENT AND
- 21 DEVELOPED BY A LICENSED PHYSICIAN OR LICENSED PSYCHOLOGIST.
- 22 Enacting section 1. This amendatory act applies to policies,
- 23 certificates, and contracts delivered, executed, issued, amended,
- 24 adjusted, or renewed in this state, or outside this state if
- 25 covering residents of this state, beginning 180 days after the date
- 26 this amendatory act is enacted into law.
