September 13, 2011, Introduced by Senators KAHN, JONES, BIEDA and MARLEAU and referred to the Committee on Judiciary.

A bill to amend 1927 PA 175, entitled
"The code of criminal procedure,"
by amending section 16d of chapter XVII (MCL 777.16d), as amended
by 2010 PA 132.
