November 10, 2011, Introduced by Senators ROCCA, JONES, BRANDENBURG, HANSEN, PROOS and WARREN and referred to the Committee on Judiciary.

A bill to amend 1927 PA 175, entitled
"The code of criminal procedure,"
by amending section 16d of chapter XVII (MCL 777.16d), as amended
by 2011 PA 169.

CHAPTER XVII

Sec. 16d. This chapter applies to the following felonies
