

SENATE BILL No. 846

November 10, 2011, Introduced by Senators ROCCA, JONES, BRANDENBURG, HANSEN, PROOS and WARREN and referred to the Committee on Judiciary.

A bill to amend 1927 PA 175, entitled "The code of criminal procedure," by amending section 16d of chapter XVII (MCL 777.16d), as amended by 2011 PA 169.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

CHAPTER XVII

Sec. 16d. This chapter applies to the following felonies enumerated in chapter 750 of the Michigan Compiled Laws:
