THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

Sec. 43526. (1) A person AN INDIVIDUAL shall not hunt deer

during the firearm deer season without purchasing a firearm deer

license. The fee for a resident firearm deer license is \$13.00.
