HAZARDOUS WASTE USER FEES: SUNSET EXTENSION

Senate Bill 959, as amended Senate Bill 960, as amended Sponsor: Sen. Roger Kahn, M.D.

A SUMMARY OF SENATE BILLS 959 AND 960 AS REPORTED FROM COMMITTEE 7-16-14:

As amended in Committee, Senate Bills 959 and 960 would extend the sunset of certain Hazardous Waste Management Program user fees for three additional years - from the current sunset of October 1, 2014, to October 1, 2017. Currently, the authority of the Department of Environmental Quality (DEQ) to collect these fees ends or "sunsets" on October 1, 2014. By changing the year in which these fees sunset, the bills would give the department the authority to continue to collect these fees until October 1, 2017.

Both bills would amend portions of the Natural Resources and Environmental Protection Act (NREPA). Senate Bill 959 would amend Part 121 (Hazardous Waste Management) and Senate Bill 960 would amend Part 111 (Liquid Industrial Wastes). These bills only extend the sunset provision of the fees and do not change any of the current fee dollar amounts. These fees are anticipated to generate approximately \$1.1 million in FY 2015.

As introduced, Senate Bills 959 and 960 would have eliminated the sunset date on the collection of these fees - which would have meant that there would be no statutory end date to DEQ's authority to collect these fees.

BACKGROUND INFORMATION:

The DEQ has the responsibility for regulating the transfer, treatment, and disposal of hazardous wastes within the state. Hazardous wastes are defined as any materials that have been identified as having the potential to cause harm to human health or the environment. The Hazardous Waste Management Program within DEQ currently monitors the management of hazardous wastes, issues permits, and assesses user charges on approximately 6,500 hazardous waste generators, 110 transporters, and 17 treatment, storage, and disposal facilities (TSDs) within Michigan.

<u>Table</u> 1 below lists the hazardous waste user fees which would be affected by Senate Bills 959 and 960. Following the table is an explanation of each of these fees:

Manifest Processing Charge

Federal and state regulations require that hazardous waste generators and transporters, as well as owners or operators of hazardous waste designated facilities, use a uniform hazardous waste manifest or shipping document for both the interstate and intrastate transportation of hazardous waste. The Manifest Processing Charge for each load of hazardous waste that is transported to any property other than the generation site is \$8.00 per manifest.

Site ID Issuance User Charge

All hazardous waste generators, transporters, and TSDs must obtain and utilize a site identification number from the DEQ in order to be involved with the transportation or reception of hazardous wastes. The one-time site identification number user charge is \$50.

Treatment, Storage, and Disposal Facility User Charge

The DEQ assesses an annual handler user charge of \$2,000 on each TSD for which an operating license is required.

Used Oil Handler Charge

The DEQ assesses an annual \$100 handler user charge on any used oil processor or rerefiner, used oil burner, or a used oil fuel marketer.

Waste Generator Charges

Hazardous waste generators must pay the following annual handler user charges based upon the amount of hazardous waste they generate:

- **Small Quantity Generator** (**\$100 fee**) --generates 100 to 1,000 kilograms in any month of a calendar year.
- Large Quantity Generator (\$400 fee) --generates 1,000 kilograms or more in any month of a calendar year and generates less than 900,000 kilograms in a year.

• Very Large Quantity Generator (\$1,000 fee) --generates 1,000 kilograms or more in any month of a calendar year and generates 900,000 kilograms or more in a year.

FISCAL IMPACT:

As amended in committee, Senate Bills 959 and 960 would extend the sunset provisions for certain hazardous waste fees paid by generators, transporters, and treatment, storage, and disposal facilities. This change would allow the DEQ to continue collecting these specific fees at their current amounts until October 1, 2017. In FY 2015, these fees are estimated to generate \$1.1 million.

<u>Table 2</u> provides a list of the hazardous waste fees that are scheduled to sunset on October 1, 2014, and how much revenue is generated by each type:

If these fee sunsets are still in effect on October 1, 2014 and are not extended, then the DEQ would no longer have the statutory authority to collect these fees and the \$1.1 million annual restricted fund revenue that they generate.
